 One transparent plastic pouch containing 106 grams of said to be Brown Sugar - seized from the possession of above noted Ruksana Khatun and marked as 'Exhibit-A'.

ii) One transparent plastic pouch containing 155 grams of said to be Brown Sugar - seized from the possession of above noted Ruksana Khatun and marked as Exhibit-B',

iii) one brown colour ladies purse stylled as Ted Baker London's seized from the possession of above noted Ruksana Khatun and marked as 'Exhibit-C',

I, PSI Newton Biswas, S/O- Nirmal Biswas of New Jalpaiguri Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against above noted accused person/lady to the effect that on 23.07..2022 at about 16.25hrs I received a specific source input that one lady were standing Passenger Shed near Beekay Plaza Plaza under New Jalpaiguri Police Station with huge quantity of brown Sugar for delivering the same to her designed customers After informing the matter to the Officer-In- Charge, New Jalpaiguri Police Station in written and being directed, I along with ASI Sajal Das, LC/746 Atashi Roy, HG/794 Ranjit Roy, VP /08 Laxman Roy, VP/ 13 Jamirul Islam, CV/ 116 Rohit Kumar Mahato and and LCV /838 Nur Nehar Banu all belongs to New Jalpaiguri Police Station left for Passenger Shed near Beekay Plaza Plaza under PS- NJP by Govt. vehicle to verify the veracity of the information vide New Jalpaiguri PS GDE No. 1171 Dtd.23.07.2022 and M.C C. NO. 1164 Dt.27.07.2022.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

At the time of departure from Police Station I took envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc.

Thereafter, we reached at passenger Shed near Beekay Plaza Plaza under New Jalpaiguri Police Station at 16.50 hrs and being pointed by my reliable source approached towards one lady accused person sitting there with a ladies purse. At that time seeing the Police party approaching towards her, she tried to fled away from the spot but, however we managed to her with ladies purse under conscious and exclusive possession of above noted Ruksana Khatun. We also contacted two persons namely ) Sukamal Sen Gupta S/O Subir Sen Gupta of Saktigarh, PS-NJP, Dist.- Jalpaiguri (2) Saumya Bikash Ghosh S/O Jyoti Prakish Ghosh of Purba Dhantala, PS-NJP, Dist.- Jalpaiguri at the spot and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed.

Thereafter, we disclosed our identity and the information in hand and stated that she will be searched in person for the purpose. At this, she after disclosing their identity as noted above admitted that she has illegally possessed brown sugar in her possession for selling the same to her designed customers as per requirement. I then gave her option in writing whether she wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer. Then she agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused persons to search our Police Party as per provisions but, they did not search the police party.
