With due respect, I am producing herewith one arrested accused person namely Babu Sarkar (29) s/o Subhash Sarkar of Haripur, Nichpara, PS- NJP, Dist.-Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

- 1. 13 (Thirty Five) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml.)
- 2.02 bottle of Tuborg Premium Beer Strong containing 650 Ml in each Bottle.3. 03 bottle of Kingfisher Strong Premium Beer containing 650 ML in each Bottle.

I, PSI-Pradeep Diyali presently attached with NJP PS under your kind control beg to state that today i.e. on 23.07.2022 at 1815 hrs I received a secret source information that one person namely Babu Sarkar (29) s/o Subhash Sarkar of Haripur, Nichpara, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his hotel at NJP Hotel Line, PS-NJP, Dist.-Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 1175 dated 22.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with HG/794 Ranjit Roy, VP/08 Laxman Roy, VP/13 Jamirul Islam, CV/116 Rohit Kumar Mahanto all of NJP PS, SPC left for NJP Hotel Line, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 1825 hrs hrs we arrived at NJP Hotel Line, and being identified by the source I held raid at the hotel of the said accused and managed to apprehended him. During interroghation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his hotel since long for his illegal gain. On search the above noted I/D liquor recovered from his house. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his house. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 1845 hrs to 1915 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Babu Sarkar (29) s/o Subhash Sarkar of Haripur, Nichpara, PS-NJP, Dist.- Jalpaiguri and arrange for its investigation.
