Sir,

With due respect, I am producing herewith one arrested accused person namely Mithun Das (39) s/o Lt. Ganesh Das of Bhaktinagar, Pipe Line, PS-NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

- (i) 15 (Fifteen) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml.)
- (ii) 04 bottle of Haywards 5000 Super Strong Beer containing 650 Ml in each Bottle.

I, ASI Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 23.07.2022 at 2015 hrs I received a secret source information that one person namely Mithun Das (39) s/o Lt. Ganesh Das of Bhaktinagar, Pipe Line, PS-NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his hotel at IOC Road, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 1175 dated 22.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with HG/794 Ranjit Roy, VP/08 Laxman Roy, VP/13 Jamirul Islam, CV/116 Rohit Kumar Mahanto all of NJP PS, SPC left for IOC Road, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 2025 hrs we arrived at IOC Road, PS- NJP, Dist.- Jalpaiguri, and being identified by the source I held raid at the hotel of the said accused and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his house since long for his illegal gain. On search the above noted I/D liquor recovered from his house. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his house. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 2055 hrs to 2125 hrs

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Mithun Das (39) s/o Lt. Ganesh Das of Bhaktinagar, Pipe Line, PS-NJP, Dist.- Jalpaiguri and arrange for its investigation.
