In producing herewith one arrested accused person namely Dipti Roy (45yrs), w/o - Lt. Hedela Roy of Sudamganj, PO- Kamarvita, PS - NJP, Dist - Jalpaiguri along with the following seized articles as per proper seizure list:

1. 12(Twelve) sealed Bottles of Galaxy Boss 60 Up Country Sprit each bottle containing 600 ML.

I, ASI. Kajal Chakraborty of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted accused person to the effect that today on 24.07.2022 at 16:05 hrs received a source information from Sudamganj area under Ambari-Falakata Out Post that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for her wrongful gain. This refers to Ambari Falakata Out Post GDE 842, dated 24.07.2022. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) LC/-1376 Leela Roy, (2) LCV/-659 Pratima Oraon and (3) CV-01 Joy Chand Roy all of Ambari-Falakata OP, Under NJP PS/SPC proceeds to Sudamganj area to work out the information. At 16:15hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the local Grocery shop, situated at Sudamganj main road and recovered the above noted articles from the possession of accused person namely Dipti Roy (45yrs), w/o - Lt. Hedela Roy of Sudamganj, PO- Kamarvita, PS - NJP, Dist - Jalpaiguri. On demand she could not produce any valid license/documents in support of said liquor. She become nervous and admitted her guilt before us and stated that she sell the same in the customer since long for her wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person in presence of witnesses namely 1) Sanjay Roy S/o. Suren Roy of Sudamganj, PO. Kamarvita, PS-NJP Dist-Jalpaiguri and 2) Suntus Roy S/o. Chakraborty Roy of do after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made in between 16:35 hrs to 16:45 hrs. Then I arrested the said noted accused person u/s 41 Cr.P.C. and issued her Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Dipti Roy (45yrs), w/o - Lt. Hedela Roy of Sudamganj, PO- Kamarvita, PS - NJP, Dist - Jalpaiguri under proper section of law.
