I, Sri Suman Paul, son of Sri Kalyan Chandra Paul and a resident of Telipara, Ashighar would like to report that I have been a victim of cyber fraud. Coming to know from Facebook advertisement, I struck a deal with one Raju Ghosh, bearing CISF no: 00053682, a commando with Dumdum International Airport and agreed to buy his vehicle bearing no: WB02AH6983 (Wagnar) for Rs. 75000. He was supposed to deliver his vehicle to my residence and I received a phone call on 23 July from the delivery asking me to contact one Nitin Kumar as the vehicle could not be delivered because of non payment of GST. I contacted him and at his behest transferred Rs 20000 on 23 July. Thereafter said Mr. Nitin Kumar asked me to pay under different pretexts and I being confused paid transferred Rs. 28500, then Rs 23500, next Rs 23400 and Rs 20000 which the attached Bank details will testify to. However, the vehicle has not been delivered and no one contacted me.

In the circumstances I, therefore, request you to take necessary steps to recover my money and find out the culprit(s).
