Sub: Voluntarily causing grievous hurt by deadly weapons such as iron rod, iron pipe, bamboo sticks with an intention to kill us, outraging the modesty of my wife and also ransacking our dwelling house by pelting stones and attempting to commit theft by 1. Nazrul Islam, Son of Late Abdul Karim, 2. Saeed - Anwar, Son of Nazrul Islam, Resident of Village-Dangapara, Post Office Balaram, Police Station New Jalpaiguri, 3. Md. Sharuk, Father's Name Not Known, 4. Md. Faruk, Father's Name Not Known Resident of Village-Jotiakhali Post office Fulbari, New Jalpaiguri Police StatioPolice Station New Jalpaiguri and 15-20 other

Siliquri Metropolitan Policimiscreants.

In connection with the above I Sri. Sushil Roy, Son of Late Pathal Roy resident of Village-Dangapara, Post office Balaram, and Police Station New Jalpaiguri would like to state that my sons Samar Roy and Swapan Roy was talking with their friends Biswakanta Roy and sariful Islam who reside nearby in front of my house when they engaged in a quarrel with one Md. Sharuk and one another at around 11: 20 p.m. as they were roughly riding the motor cycle. As such quarrel and hot altercation was going on Md. Sharuk started assaulting my son and called several other persons over phone as I heard the quarrel I rushed in front of my house and stopped them and was about to take my two sons inside our house at such moment about 15-20 other men reached in front of my house armed with iron rod, iron pipe and bamboo sticks at around 11:45 p.m. and started abusing me, my two sons and my wife using filthy and foul languages. They then started
