That dated 25/7/22 Monday my wife ASHA DEVI BHARWAL left home for errand by locking the Main Door at approx 12.15 PM after a hour at approx 1.15 PM when she returned home & found that the door lock were broken, after entering the place she found that the valuable kept in the room was also open & lights were on, steel Almirah lock were broken & the valuable held ornaments approx 500000 contents: (1) 3 pc gold necklets (2) 2 pair of <sup>can</sup> rings (3) 1 pc of ear ring (over one unlost) (4) 2 pc of gold ring from the locker which was hidden in middle of steel Almirah & silver ornaments approx 2-1/2 kg (1) 1 kg of raw silver balls (2) 100 pc of silver coin (3) ~~2~~ 3 Baby Bangles (4) Payal & pajeets, and also from the above locker of steel Almirah (1) 5 pair of ear rings for daily use (2) 5 pc of gold ring and few extra ornaments along with silver photo frame 2 pc along with this cash of Rs 30000/- approx was also missing from the above locker. She informed the matter on mobile phone to me.

So, I therefore request you to investigate and recover all the belongings ornaments of gold & silver along with the cash to book the culprit under the law oblige.
