Respected Sir,

With due regards, I, SMT. RINI DAS (CHAKRABORTY), Wife of Sri Kaustav Chakraborty, Daughter of Late Manik Das, Presently residing at Rathkhola, Opp. Radha Gobinda Mandir, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, Pin: 734006, would like to lodge this written complaint before your good office to the effect that SRI KAUSTAV CHAKRABORTY, Son of Sri Kishore Chakraborty, Resident of 370, Najrul Sarani, Chayan Para, Ward No. 37 of S.M.C., P.O. Ghogomali, P.S. Bhaktinagar, Dist. Jalpaiguri, Pin: 734006, is my legally married husband and our marriage was solemnized on 07.05.2014, as per the provision of the Special Marriage Act, 1954, before the Ex-Officio Marriage Officer & A.D.S.R. - Siliguri, vide Registration No. 122/2014. Sir, it is pertinent to mention here that I got acquainted with said Kaustav Chakraborty i.e. my husband in the year of 2010, in the Institute namely North Bengal Art Academy, where I used to take class of singing and my husband was the Key Board Teacher of the said Institution and on being acquainted with each other, he asked and requested me to join and perform for his band and thereby, he along with one of his friend namely Sri Baban Saha used to visit at my parental house on regular basis in order to grow my confidence to join and perform for his band and due to his constant request, I have agreed with his said proposal and thereafter, I have also started to visit at his house as mentioned aforesaid to join and practice with his said band and also to take tuition from his father. During my visit at their house, my Mother-In-Law namely Smt. Shukla Chakraborty made a proposal before me and my mother to negotiate my marriage with her son i.e. Kaustav but initially, we have refused the said proposal as at that time, I was pursuing my studies in Class - XII. On being refused their proposal, my husband started to induce me to accept his proposal for marry on different ways and always tried to convince me and my family members. It is to be mentioned here that in the mean time, I came to know that my husband has a affairs with another lady and on being asked, he told me that it's a rumor and in fact, he has no other relation with any lady besides me and also assured me that he wants marry me and believing his said version, I have also agreed to marry with him and subsequently, our marriage was solemnized on 07.05.2014, in presence of one friend and two brothers of my husband and at the time of registration of our marriage, on several times, I asked and requested him to inform our respective family members about our said decision but he has flatly refused to inform the same to his family members and also threatened me that if I will inform them, he will not lead conjugal life with me and considering the said situation, I also keep mum. Sir, it is very painful to mention here that immediately after registration of our marriage, my husband told me to visit at my parental house as he needs some times to arrange accommodation for our future conjugal life as at present, his parents are not water to accept me as their daughter-in-law in their house and hearing the same, when a

asked him about the reason, my husband told me that his parents heard from elsewhere that I am the adopted daughter of my parents and I have no genealogical identity which I have flatly denied but at that time, my husband assured me that if his parents will not allow me in their house, he will arrange a separate accommodation and took me there to reside with me as husband and wife and hearing the same and believing his said version, I have also agreed. In the mean time, my parents-in-law came to know about our said marriage and immediately after knowing the said facts, my mother-in-law called my mother over phone and abused her with filthy and abusive languages and my brother-in-law also throws some abusive and offensive languages towards me which tentamounts to a modesty of a woman and also threatened me to handover our Marriage Registration Certificate in their favour as they are not accepting our said marriage but we did not make any protest against my in laws members considering my future conjugal life with my husband with a hope that they will realize their own mistake and thereby, rectify themselves and accept me in their house as their daughter-in-law but no fruitful result occurred and I was waiting for that moment with a hope that they will allow me and brought me in their house in order to pay honour me as their daughter-inlaw and my husband always tried to understood me that he will definitely took me at their house as his legally married wife but my husband did not take any initiative to take me at their house at any point of time. After few years, my Mother-In-Law came to our house and told me that they have decided to arrange a social marriage ceremony in their house as they gave their consent in the said marriage and as per their assurance, I along with my family members became so happy and started to arrange our social marriage ceremony. Thereafter, on 22.07.2018, my family members and other relatives went to my matrimonial house in order to perform Ashirbad Ceremony and on day of Ashirbad Ceremony, my parents have given a Golden Chain, Wrist Watch, Clothing to my husband as per their demand. It is also to be mentioned here that immediately after our Ashirbad Ceremony, my husband asked and requested my mother to pay a sum of Rs. 50,000/- only as he requires the same to repair his house prior our marriage ceremony and also assured my mother that he will return back the said amount after few months and as per his request and assurance, my mother has paid a sum of Rs. 50,000/- only to my husband considering my future conjugal life but still now, he did not return back the said amount. Thereafter, my husband and in laws members have placed different types of demands before me and my family members as dowry though, it is very much within their knowledge about the poor financial stability of my parents but inspite of that, my parents have compelled to agree with their said demands considering my future conjugal life and subsequently on 27.01.2019, a social marriage ceremony was performed in my parental house as per the Hindu Rites and Customs and on the day of social marriage ceremony, my parents and other nearest relatives have given so many Golden & Silver Ornaments, Furniture & Fixtures, Utensils, Clothings and other valuable articles including cash as per the demand of my husband and his family members. After our marriage ceremony, my husband brought me in my matrimonial house wherein, we have started to reside as husband and wife and I have entered into my matrimonial house with lots of dreams and hopes to lead a happy and glorious conjugal life with my husband but immediately after entering into their house, my mother-in-law asked me to handover all my golden ornaments and other valuables including the gifts which I have received at the time of marriage ceremony. in her favour by stating that they have already incurred a huge expenditures towards our marriage and they wanted to took the custody of those ornaments in their feeting

and as per her demand, I have compelled to handed over all my golden ornaments, gifts and other valuable articles in her favour without asking any question for the sake of our future conjugal life and since then, the same are lying in the custody of my mother-in-law. Sir, inspite of obeying all the conditions of my husband and in laws members, after our marriage, I have found and noticed some radical changes in the attitude and behavior of my husband and his family members towards me. They always showed their dissatisfaction towards me as their daughter-in-law and taunting my in different ways. Sir, after entering into my matrimonial house, I have also found and noticed that my Brother-In-Law is a person of bad character and he in connivance with the other family members, have involved in the several illegal antisocial activities and they have running prostitute business in their house by evading the eyes of law and on regular occasion, they brought several young girls in their house and engaged them in the line of prostitution wherefrom, they used to earn money but due to fear of death, I have compelled to keep mum. After our marriage, my husband in conspiracy with my in laws members have dispersed the maid servant of their house intentionally and forced me to do all the household chores in their house and as per their direction, I was doing all the household chores in my matrimonial house as a maid servant but as and when, I asked them about my future study, they flatly refused to allow me to continue my study and on contrary, they tried to invoke some false allegation upon me with an intention to stop my study and when I requested them to allow me to complete my studies, they have confined me in a single room without having any food and water and started to create tremendous mental and physical torture upon me in a barbaric manner and they have also restricted me not to touch and use any household articles like refrigerator, kitchen, toilet, electrics equipments without their consent and permission but I used to bear such type of torture considering my future conjugal life but they never tried to understood me and my husband also refused to pay any amount towards my educational fees. Thereafter, finding no other alternative, I have informed the matter to my mother and after hearing the same, she used to pay the educational fees and other expenses to me and when the said fact came to the knowledge of my husband and in laws members, they have started to threaten me with dire consequences not to talk with my mother and they have also clearly stated that they will not allow me to complete my studies from their house and if I again try to talk about my future studies, they will not hesitate to oust me from their house and thereafter, finding no other option, I went to my parental house in order to complete my future studies. In the mean time, in the month of February, 2021, I came to know about my pregnancy and after confirming the said news, I return back to my matrimonial house and informed the matter to my husband and in laws members but hearing the same, they became more furious and asked me to abort the same as my husband was not ready and willing to take child at that moment and also refused to take any responsibilities towards my unborn baby and hearing the same, when I make protest against his such type of behavior, my husband in conspiracy with his family members have started to pick up quarrel with me on any tripling issues and also shifted the entire burden of the household chores upon me and compelled me to do all the household chores in my matrimonial house even during the time of my pregnancy. Day by day, they have started to create tremendous mental and physical torture upon me and did not bother to think about my heal condition and they have also stopped to provide me sufficient foods in order to create more pressure upon me and sometimes, I used to sleep at night in empty stomach but I used to bear such type of torture of my husband and in laws members with a hope that in near future, they will definitely realize their own Page | 3

35/7/2008/6/10 mistake but all my hopes have gone in vain due to their continuous torture and when I was advance stage of my pregnancy, in the month of July, 2021, my husband in

conspiracy with his family members have ousted me from my matrimonial house and before that, they assaulted me by pressing my throat with an intention to kill me and finally, they left me at my parental house forcefully and since then, I have been residing at my parental house and during my stay at my parental house, I gave birth a female child on 08.07.2021 at New Ramkrishna Seva Sadan, Siliguri, whose name is Miss Gitisha Chakraborty and the entire expenditures towards the delivery of my said child was incurred by my mother and knowing the delivery of my child, my husband being the father of the said child, has flatly refused to take any responsibility. Sir, after the birth of the said child, I again went to my matrimonial house with my newly born child with a view to lead a happy conjugal life with my husband but immediately after entering into my matrimonial house, my husband and mother-inlaw have restrained me to enter into their house and asked me bring money from my mother towards the expenses of my newly born child and when I denied the same, they became more furious and ousted me from their house forcefully and finding no other alternative, I have compelled to take shelter at my parental house with my minor daughter and since then, I have been residing at my parental house in a single wearing apparels. During my stay at my parental house, my husband only paid a sum of Rs. 25,000/- only (Rs. 5,000/- each on five occasions) towards the maintenance of our daughter as per my request. Thereafter, suddenly on 26.04.2022, I have received a Legal Notice from the engaged lawyer of my husband Mr. Somnath Saha wherein, my husband has made some false and vague allegations against me with ill and malafide intention and by the said legal notice, he asked and requested Qui med on 94.07 2 me to comeback in the matrimonial society of my husband and immediately after receiving the said notice, I have made contact with my husband and told him that I am also still ready and willing to lead a happy conjugal life with him and also asked him when I will come to his home but he flatly denied the same and told me that only in order to safeguard himself from the legal consequences, he sent this Legal Notice to me and in fact, he has no love and affection either towards me or towards my child. Sir since last few months, my husband through his engaged persons and other relatives have continuously threatened me with dire consequences and also created pressure upon me to give my consent in the mutual divorce as he is no more interested to lead further conjugal life with me as his parents have already negotiate his marriage with another lady and when I refused to accept his said proposal, he along with his family members have started to threaten me by saying that if I will not give my consent in the mutual divorce, he will not hesitate to ruin my life as well as the life of my minor daughter permanently. Sir, due to the continuous torture of my husband and in laws members, I have been passing my days with extreme fear and anxiety and passing my days with my minor daughter with great starvation.

> I, therefore, request you to investigate into the matter and please take appropriate strong legal action against my husband and in-laws members as per the provision of law and obliged thereby.
