Sub:- Complaint against one Shiva and other seven (7) for assaulting me mercilessly with the intention to murder me.

Respected Sir,

I am Ali Moizuddin, S/O Bashiruddin of 71 Masjid Road, Ashraf Nagar, Haidepara, Siliguri, Jalpaiguri-734006 do state to you as follows:-

That I am a 3rd year student of Munshi Premchand Mahavidyalaya.

That it is pertinent to mention here that some outsiders and former students one namely Shiva and Seven others whom I do not know by name but can identify when seen, keep visiting our above mentioned college and create nuisances every now and then and the same is known to the college authorities but for reasons best known to them they never raised any objection to it.

That today at about 1:30 PM the said miscreants as mentioned above were disturbing one of my classmates who is a specially abled child inside the college campus and at that time I was passing from there and seeing the painful site I raised protest against the unruly behaviour of the miscreants and tried to take away my batch

teachers came there and inquired about the incident and when I was explaining him the incident, the miscreants got angry and violent and then in front of the teacher they started abusing me in the filthiest languages and then by aiming on my head the miscreants started assaulting me. At the same time they tried to assault my classmate and my teacher rushed to save him.

That thereafter the accused person with a view to teach me a lesson and also ensure no one dares to raise protest against them dragged me from outside the main gate of my college and while dragging me they kept assaulting me mercilessly and brutally. They assaulted me on head by dropping me down outside the college gate by closing the door so as no one could come to rescue me with their only intention to murder me as the the miscreants started shouting "aaj eke amra mere felbo", I tried protecting myself with my hand and for which I sustained injuries on my right forearm and also on the right side of my scalp.

Sir, most of the incident has been captured in the college CCTV cameras and after the incident they left me outside the college main gate and threatened me against taking any legal recourse against them or else I shall face dire consequences and they also

threatened anyone who would testify against them including the teachers of the college and also the special student who was being harassed.

th. that after the miscreants left i was rescued by my fellow batch mates and informed the entire unfortunate incident to our Principal who till now has taken no legal steps against the miscreants.

That after the incident I was taken to Siliguri District Hospital where I was medically treated as I was suffering with concussion and acute pain on the right side of my scalp along with injuries all over my body.

Sir, we go to the temple of education being our college to be imparted with the best education and also to ensure we as law abiding citizen do report all illegal activities around us and also stand tall against the same but today the incident left me completely traumatized and I have now started to fear for my life due to the activities of the miscreants and as such I request you to take stringent action against the accused person and ensure my safety in my college.
