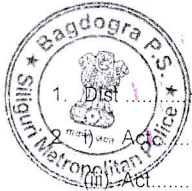

Dear Sir,

I, SRI DIPAK SAPKOTA, Son of Late Chandraman Sapkota, residing at Rupsingh Jote, Gossainpur, Post Office & Police Station - Bagdogra, District - Darjeeling, in the State of West Bengal, do hereby begs to state as follows:

1. That one Pinky Sinchuri @ Singh, Daughter of Man Bahadur, presently residing at Gardenia Apartment, B Block, Room No. 107, Devidanga, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling was a good friend of me as a result she have approached me for her financial hardships and on 05.10.2016 I gave her a sum of Rs.3,00,000/- (Rupees Three Lakhs) only by cash Rs. 80,000/- (Rupees Eighty Thousand) only and Rs. 2,20,000/- (Rupees Two Lakhs Twenty Thousand) only through Bank Transfer and she promised me to repay the amount within 30.11.2016.
2. That the said Pinky Sinchuri @ Singh after the lapse of stipulated time could not be able to repay the sum of Rs.3,00,000/- (Rupees Three Lakhs) only to me.
3. That thereafter the said Pinky Sinchuri @ Singh along with her close friend namely, Rabin Darji @ Robin Dorji, son of Tek Bahadur Darji, resident of Dhemaal, P.O. New Rangia, P.S. Matigara, Dist. Darjeeling, who use to work with Pinky Sinchuri @ Singh in land matters as broker approached me to purchase a land measuring 5 Kathas, situated at Mouza Dhemaal, J.L. No. 83, recorded in Khatian No. 292, in L.R. Plot No. 101, R.S. 40, under P.S. Naxalbari now Bagdogra, Dist. Darjeeling and said that the amount of Rs.3,00,000/- (Rupees Three Lakhs) only taken from me by the said Pinky Sinchuri @ Singh shall be cleared and I had to pay no money for purchasing the said land.
4. That the aforesaid land's actual owner was Sri Pritam Sharma, son of Ganesh Prasad Sharma, resident of Sadar Darjeeling.
