Respected Sir,

I, **MD. ALIMUDDIN**, Son of Md. Kamia, resident of Panchkulguri, P.O.- Nimai, P.S.- Matigara, Dist.- Darjeeling, would like to lodge this complaint that my three sons viz. Md. Habibul, Md. Mimirul and Md. Abidul have jointly purchased the land measuring 1 Acre or more or less 99 Decimal, by virtue of a registered Deed of Sale being No.- I- 6257 for the year 1990 and since then, they have been jointly using, enjoying, occupying and possessing their aforesaid land peacefully and uninterruptedly, by mutating their names in the Record of Rights being Khatian Nos.- 295, 296 and 297 respectively of Mouza- Panchkulguri, under L.R. Plot No.- 334 within Police Station- Matigara, Dist.- Darjeeling.

Sir, very recently I have come to learn that **1. Bijay Kumar Sah**, Son of Ram Khelawan Sah, resident of Salbari, P.O.- Salbari, P.S.- Matigara, Dist.- Darjeeling, **2. Md. Rajab @ Rajab Ali @ Rajab Mahammad**, Son of Tamizudin Md., resident of Damragram, Salbari, P.O.- Gulma, P.S.- Pradhannagar, Dist.- Darjeeling, **3. Sri Gunga Munda @ Dilip Munda**, Son of Tepai Munda, resident of Helapakhri Jote, P.O.- New Chamta, P.S.- Matigara, Dist.- Darjeeling and others, in connivance and in collusion with each other and also with the B.L. & L.R.O., Matigara, have illegally procured and manufactured false Khatians in their names by unlawfully deleting the names of my sons from the Record of Rights and thereby they have fraudulently and dishonestly converted my sons land into their land, without purchasing the same, with a clear intention to cheat us and also with an dishonest intention to misappropriate the property of my sons, who are the bonafide owners.

Sir, subsequently, I have also come to learn that the aforesaid persons have illegally executed several forged Deeds in the names of several persons by illegally disposed of the land of my sons and from such illegal transactions, the aforesaid persons have fraudulently earned a huge sum of money near about Rs. 1 Crore and thereby the aforesaid persons have illegally misappropriated said huge sum and in this way, they have not only cheated my sons, but also cheated several people, as they are well-known "land mafias" in the locality.

Sir, I have also come to learn that the aforesaid persons are used to procure several fake identity cards like Voter Card, Aadhar Card and Driving License

by using their different fake names for the purpose of grabbing the land of innocent persons and also earned huge illegal money therefrom by using said forged documents with the help of B.L. & L.R.O., Matigara and in this way, they are continuously cheating several people. The aforesaid person have used their said fake documents for procuring forged documents to deprive a large number of people of Matigara and Salbari area.

Sir, I have also come to learn that the aforesaid persons also manufactured and procure official Government seal and forged the signatures of Govt. officials for cheat the public and all the aforesaid persons also destroyed and tampered the Govt. documents for their illegal and malafide gain.

Sir, I, therefore, am humbly requesting you to register my complain in your F.I.R. register and also to take an immediate drastic actions against said **Bijay Kumar Sah, Md. Rajab @ Rajab Ali @ Rajab Mahammad, Sri Gunga Munda @ Dilip Munda** and others in accordance with law. Your Good office and urgent co-operation is very much expected in this regard.
