and inlaws have stolen away my all
the belonging, so I request you to look into
the matter. Moreover my husband took all
my goods and when I questioned then he
started threatening me and tried to kill me
and my baby.

So, I request you to look into the matter and
do the needful to recover my goods and provide
me the protection for saving me and my
son's life.
