Respected Sir,

With due regards, I, **SMT. SUDHA DUTTA (SAHA)**, Wife of Sri Pankaj Saha, Daughter of Sri Kali Dutta, Presently residing at Rabindra Nagar, Siliguri, Ward No. 21 of S.M.C., P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, would like to lodge this written complaint to the effect that **SRI PANKAJ SAHA**, Son of Sri Nabin Kumar Saha, Resident of Dasarath Pally, Ward No. 44 of S.M.C., Siliguri, P.O. & P.S. Bhaktinagar, Dist. Jalpaiguri, is my legally married husband and our marriage was solemnized on 17.02.2022, according to the Hindu Rites and Customs, after observing all formalities of a Hindu Marriage on and from the Kalibari at Shiv Mandir, Matigara. It is to be mentioned here that our marriage was the outcome of our previous love and affairs and we got acquainted with each other since last 3½ years ago prior to our marriage and when the marriage was solemnized, I was a student of B.A. 3rd Year of Siliguri College and in fact, without the consent of my family members, I entered into the said marriage with Pankaj Saha. After our marriage, we stayed together as husband and wife for a period of 07 days at the maternal uncle's house of my husband at Shiv Mandir, Matigara and thereafter, I was brought by my husband at his parental house at Dasarath Pally, Siliguri, where we have started to live together with his family members as husband and wife. After our marriage, we have passed our marital life more or less happily for a period of one month and after crossing one month of our marriage, I have noticed and found some adamant attitude and behavior of my husband. He always used to return back home at late hours with fully drunken condition and started to abuse me with filthy and abusive languages and if I asked him as to why he return back home in the late hours with a drunken condition, he did not bother to assault me physically and such type of incident occurred on numerous occasion. I have requested my parents-in-law and other in laws members to

understood my husband not to consume alcohol on regular basis and also requested them to understand my husband to behave properly with me and in fact, my parents-in-law and other in laws members tried their level best in order to restrain my husband from doing such type of ill activities but my husband did not pay any heed to their request also. Prior one month's ago, my husband came back at home with a full of drunken condition in the late hours and started to quarrel with me without any just cause and reason and when I make protest against his such type of behavior, he became furious and kicked me on my abdomen and as a result, I received some injuries on my person and thereafter, I left my matrimonial house and took shelter at my friend's house. Thereafter, my husband and my parents-in-law have reached there and in presence of my parents-in-law, my husband makes apology before me and assured me that in near future, he will not commit any torture upon me either mentally or physically and receiving such type of assurance from my husband, I again return back to my matrimonial house with my husband with an intention to lead a happy conjugal life with him but after passing 07 or 10 days, my husband again return back to his earlier acts and attitude and he started to inflict torture upon me on regular basis. My husband also threatened me with dire consequences by saying that I should obey all the directions of my husband otherwise, he will not hesitate to destroy my life as well as the life of my family members. Yesterday i.e. on 25.07.2022 also, he again started torture upon me and due to the unbearable torture of my husband, I have compelled to leave my matrimonial house and took shelter at my parental house and it is my strong believe and apprehension that he may come/visit at my parental house at any point of time and destroy my life permanently.

I, therefore, request you to investigate into the matter and please take appropriate strong legal action against my husband as per the provision of law and obliged thereby.
