Respected Sir,

With due respect I, Ram Shankar Das, S/O Late Sita Ram Das, resident of Demdema, under Dabgram I Panchayat, P.O. Salugara, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal begs to state that on 25.07.2022 at around 07:30 pm I was returning from Salugara Bazar to my home at Ghat Road, Demdema, under Dabgram I Panchayat, P.O. Salugara, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal one Sunil Das (Roy), S/O Not Known, resident of Shanti Para, P.O. Salugara, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal and two other unknown person from the same area started assaulting me without any rims and reasons. That the aforesaid person started assaulting me with fist and blows and when I tried to stop them they started assaulting me with wooden battams and rods. The said road or *gully* is usually filled with goons and drug addicts during night time. The aforesaid persons attacked me and shoved me into the drain and assaulted me with a motive to kill me and because of which I sustained severe injury in my face, head and neck of my body. I had to have stitches in my face. The aforesaid person after assaulting me snatched and stole one silver chain from my neck and a cash amount of Rs. 5,000/- (Rupees Five Thousand only) from my pocket. That after hearing the noise some person from that locality arrived and the aforesaid persons ran away from the spot. I somehow managed to save my life and reach my house and thereafter my family took me to Nayak Nursing Home, Sevoke Road, Siliguri for my treatment. The aforesaid persons are very desperate in nature and can take law in their hands in the future as well.

So I therefore request before you to kindly look into the matter and start a specific case against the afore said Sunil Das (Roy), S/O Not Known, and two other persons all are resident of Shanti Para, P.O. Salugara, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal under the provisions of law.

I shall be highly obliged for this act of kindness.
