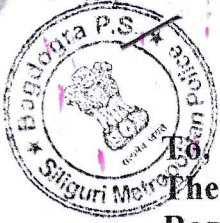

Sub-Complain

I, **Smt. Basanti Mahato** W/O Sri Sanjay Prasad D/O Sri Kameshwar Mahato, resident of C/O Bala Ram, Near Durga Mandir, Ho-Chi-Min Nagar, Upper Bagdogra, P.O. & P.S. Bagdogra, Dist. Darjeeling, beg to report you that on **19.06.2022** at about **9.00 pm** when my elder sister Miss. Mira Mahato D/O Sri Kameshwar Mahato who is mentally unstable was returning home after fetching water from the government tube well suddenly she was intercepted by three men namely 1. **Ravi Mallick S/O Raghunath Mallick** resident of C/O Bala Ram, Near Durga Mandir, Ho-Chi-Min Nagar, Upper Bagdogra, P.O. & P.S. Bagdogra, Dist Darjeeling, 2. **Kishan Basfore** S/O Late Shambu Basfore resident of Near Kedarnath School, Upper Bagdogra, P.O. & P.S. Bagdogra, Dist Darjeeling and 3. **Suman Basfore @ Langda** S/O Unknown resident of Tuna Basti, Gangaram, Tea Estate, P.O. & P.S. Bagdogra, Dist. Darjeeling, suddenly caught hold of my sister from behind when she had reached in front of our gate and started hitting her in her head with fists and blows and was snatching her hair without any rhyme and reason as a result of which she got serious injury in her head. In order to save her from these complained persons my younger brother Sani Mahato, my mother Smt. Mina Devi Mahato and me and my other family members also came out to save her from these devil persons.

That thereafter they followed us till our house. At that time Ravi Mallick's mother 4. **Smt Bachiya Devi** and sister 5. **Smt Chanda Mallick** and her husband 6. **Sri Shyam** 7. **Raju Mallick** who also resides at the same neighborhood joined the three men and started abusing all our family members in filthy language including myself, my mother, my father and other relatives. After that they started hitting us also with fists and blows randomly. That **Chanda Mallick** grabbed my neck so hard that I started choking; she also ripped apart my clothes and humiliated me in front of lots of people who had gathered there by that time after hearing our hue and cry. In the meantime, Chanda Mallick was joined by her other two sisters 8. **Smt. Rita Mallick** and 9. **Smt. Anita Mallick** and their daughters 10. **Miss. Isha Mallick**, 11. **Miss. Kumud Mallick** and 12. **Miss. Sadhna Mallick**, who grabbed my hair and pulled it so hard that my head started spinning very badly and I got nausea and felt like vomiting. **Chanda Mallick** also slapped my father and hit my mother in her head as a result she suffered head injury.
