In producing herewith one arrested accused person namely Sunity Roy Barman (32yrs), W/o - Gopal Roy of Gokulvita, PO- Kamarvita, PS - NJP, Dist - Jalpaiguri along with the following seized articles as per proper seizure list:


1. 12(Twelve) sealed Bottles of bottles of Boss 60 Up country spirit each bottle containing 600 ML.

I, ASI. Sailendra Singh of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted accused person to the effect that today on 26.07.2022 at 13:55 hrs received a source information from Gokulvita area under Ambari-Falakata Out Post that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for her wrongful gain. This refers to Ambari Falakata Out Post GDE 919, dated 26.07.2022. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) LCV/-859 Jahanara Khatun (2) LCV-424 Tumpa Basak and (3)C/-505 Tapash Dutta all of Ambari-Falakata OP, Under NJP PS/SPC proceeds to Gokulvita area to work out the information. At 14:45hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the local shop, situated at Gokulvita and recovered the above noted articles from the possession of accused person namely Sunity Roy Barman (32yrs), W/o - Gopal Roy of Gokulvita, PO- Kamarvita, PS - NJP, Dist - Jalpaiguri. On demand she could not produce any valid license/documents in support of said liquor. She become nervous and admitted her guilt before us and stated that she sell the same in the customer since long for her wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person in presence of witnesses namely 1) Biswajit Chanda S/o. Lt. Purna Chandra Chanda of 09 No. Colony, PO. Kamarvita, PS-NJP Dist-Jalpaiguri and 2) Pranab Choudhury S/o. Lt. Balai Chowdhury of 09 no. Colony, Ambari-Falakata, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made in between 15:05 hrs to 15:20hrs. Then I arrested the said noted accused person u/s 41 Cr.P.C. and issued her Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Sunity Roy Barman (32yrs), W/o - Gopal Roy of Gokulvita, PO- Kamarvita, PS - NJP, Dist - Jalpaiguri under proper section of law.
