In producing herewith one arrested accused person namely Chandan Sarkar (36yrs), S/o - Narayan Sarkar of Gokulvita, PO- Kamarvita, PS - NJP, Dist - Jalpaiguri along with the following seized articles as per proper seizure list:

1. 11(Eleven) sealed Bottles of King Fisher Strong each bottle containing 650 ML.

I, SI. Rakesh Debnath of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted accused person to the effect that today on 26.07.2022 at 15:05 hrs received a source information from Gokulvita area under Ambari-Falakata Out Post that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE 925, dated 26.07.2022. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) C/-625 Bhabendra Das (2) NVF-131 Bidhan Roy and (3) VP/-14 Paritosh Roy all of Ambari-Falakata OP, Under NJP PS/SPC proceeds to Gokulvita area to work out the information. At 15:25hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the local shop, situated at Gokulvita and recovered the above noted articles from the possession of accused person namely Chandan Sarkar (36yrs), S/o - Narayan Sarkar of Gokulvita, PO- Kamarvita, PS - NJP, Dist - Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that she sell the same in the customer since long for his wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person in presence of witnesses namely 1) Pritam Shekher Das S/o. Lt. Goutam Das of Kamarvita, PO. Kamarvita, PS-NJP Dist-Jalpaiguri and 2) Abhijit Majumder S/o. Lt. Ashim Majumder of Ambari-Falakata, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made in between 15:40 hrs to 15:52hrs. Then I arrested the said noted accused person u/s 41 Cr.P.C. and issued him Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Chandan Sarkar (36yrs), S/o - Narayan Sarkar of Gokulvita, PO- Kamarvita, PS - NJP, Dist - Jalpaiguri under proper section of law.
