At about 1635 hrs myself along with officer and force arrived at Micheal Madhusudan Colony and being shown and identified by the source we held raid at the house of accused person namely Gouranga Das s/o Lt. There was sufficient reason to believe that the said 13 numbers of mobile phone and other electronic Gadgets are stolen. Accordingly, I seized all the A13 (thirteen) numbers of recovered mobile phone, Head phone, Blutooth Speaker, Pendrive under proper seizure list and arrested both of them under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure and arrest was made in between 1805 hrs to 1845 hrs.

Under the above noted fact and circumstances, I therefore pray before you that a specific case under proper section of law may kindly be initiated against the accused persons namely (i) Joy Deb Das (18) s/o Babu Das of Micheal madhusudan Colony, PS-NJP, Dist.- Jalpaiguri (ii) Gouranga Das (18) s/o Lt. Goutam Das of Micheal Madhusudan Colony, PS-NJP, Dist.- Jalpaiguri and arrange for its investigation.
