SUB:- Written complaint against my daughter-in-law namely 1. Debjani Roy Haldar w/o Chiranjit Roy and her mother namely 2. Sewly Haldar Mukherjee, 3. Shri Chandan Mukherjee (Maternal uncle of Debjani Roy Haldar) of Vivekananda pally near lion's club, katowa alongwith some women out of which some wearing all white colour churidar with red gamcha.

SIR,

With due respect I Shri Megnath Roy S/o Late Krishna Kr Roy of 7/4, Ashok Nagar Ward no- 31, Siliguri Bazar, P.S- NJP, Dist- Jalpaiguri would like to inform you that on 06.07.2022 at about 6 p.m. the aforesaid persons along with 10 to 15 women forcibly entered into my house at that time I being a father-in-law advised my daughter-in-law, Debjani Roy Haldar and her mother to go to my son's residence who is not resided with us however the mother of Debjani Roy Haldar created pressure upon me and my wife to take the all responsibilities of her daughter at that time I somehow I was able to convince them by saying that we have no relation with my son thereafter the aforesaid persons left my house but suddenly after departure of the aforesaid person I was feeling severe suffocation and uneasy as a result next day on 07.07.2022 at about 4 am I along with my wife went to Kolkata by Satabdi Express for my treatment and after taking some treatment we heard a news at about 6.30 p.m. on 08.07.2022 from my tenant Bikram @ Tablu Das S/o Haripada Das that aforesaid persons and probably one NGO (All are women wearing white color churidar along with gamcha) are very aggressive waver entered in my house after breaking the several locks and also ransacked my house my tenant also resisted them but the aforesaid persons ignored my tenant by hurling filthy languages as a result we return from Kolkata by flight on 09.07.22 at around 2 pm and since then my daughter-in-law continuously threat me with dire consequences that my aforesaid daughter-in-law and her mother and her persons probably broke my all locks wherein all original papers like Sale Deed, LIC Papers, bank Papers, Cheque Books etc and Cash Rs- 1,00,000/- (One Lakh) and all gold ornaments like three gold chain (12g, 14g, 12g). And another gold chain which was kept in freze weight approx 22.7 grm and one bichahar, finger ring, one pair Bala, one Churi are stolen by them. They also broken the CCTV camera which was install by me to destroy the evidence and they also driven out my tenant after prolong torture of them. Thereafter on 18.07.2022 at about 2.30 p.m. I along with my wife tried to visit my house but they resistance me and my wife by saying that I have to transfer my house immediately in the name of my daughter-in-law and I also requested her to enter into my room to bring money then she told me that " Ami kichu dibo na baire ja jaa kichu aache sob ami niye niyechi.....Tumader kichu karar thake ja khushi kor ar akhan tike chole jau Akhuni" my daughter-in-law also physically assault my wife. Since 09.07.2022 I along with my wife being both are senior citizen moving here and there shelterlessly. However being a senior citizen we are entitled to right of peaceful residence in our own house to the exclusion of all, my daughter-in-law voluntarily left our house for which my son filed a divorce petition before the Ld. District Judge Jalpaiguri in the month of May, 2022. Probably 20.07.2022 at around 4 p.m. I along with my wife again tried to enter into my house but door was closed under a pad lock that aforesaid Chandan Mukherjee being a maternal uncle of Debjani Roy / Haldar continuously threatening us through phone from katwa with dire consequences. Ultimately on 22.07.2022 my wife became seriously ill as a result I admitted her Heritage Nursing Home at Jhankar More, Burdwan Road at about 2.30 p.m. wherein she was admitted under the Dr. of S.K Choudhary and released on 25.07.2022 in the evening time for which some unintentional delay is appeared to lodged this complaint.

Therefore, you are requested to arrest/booked the aforesaid persons from my residence and recover all my belongings from the hand of my daughter-in-law and her mother so as to we can peacefully reside in my own house without any interruption from any corner/corners and also protect us from the hands of aforesaid persons.
