**SUBJ: COMPLAINT AGAINST PUJA TASSA, RAJESH TASSA  
AND SATYENDRA KUMAR YADAV REGARDING THEFT AND  
MAKING THREATS TO KILL ME AND MY FAMILY**

Respected Sir,

1. I, Govind Singh Rautela, son of Kharak Singh Rautela, Army by profession, presently residing at Shree Balaji Enclave, Pipeline, Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri would like to register a complaint against 1. **Puja Tassa**, W/o Rajesh Tassa, 2. **Rajesh Tassa** s/o Late Prem Prasad Tassa, both permanent resident of Nagoan, P.O. Panitola, P.S. Chhabua, Dist. Tinsukia (Assam), currently residing in Siliguri, and 3. **Satyender Kumar Yadav working with Allen Institute, as a Marketing Supervisor**, regarding making threats to kill me and my family.
2. My job requires me to move from one place to another. When I was posted at Military Station Dinjan Dist. Dibrugarh (Assam) I had hired Puja Tassa as a maid. Later in November, 2020 I was posted to Salugara, Siliguri, I started staying at Shree Balaji Enclave. I brought her along with my family to Siliguri to help me out with the relocation. After the relocation was done I paid her and she left for her home.
3. In the last week of June, 2021 my wife got a call from Puja Tassa asking for a job and she told her she is not getting a job at her place in Assam and her family is starving and couldn't afford to even eat once a day. After a long discussion with my wife, we agreed to let her work at our home as a maid and even arranged a place for her to stay while she works here. I arranged for her travelling expenses and even paid her advance amount so she and her family could get by.
4. Puja Tassa with her husband Rajesh Tassa and her two daughters arrived on 13<sup>th</sup> July, 2021 and she started working in my flat as a maid and her husband found work at a shop.

5. After a month Rajesh Tassa came to me saying that they had borrowed an amount of Rs. 31,000/- as a loan and it was due to be repaid and he was getting repeated threats from the lender. He requested me to help him pay back the amount and he will pay me back on an EMI basis. With his request I paid off his loan.

6. In the month of December, 2021, she told my wife that she was not willing to stay at the place we provided and wanted to live on her own and she shifted. And last week in the month of February, 2022 she told my wife that she does not want to work at my home and left. After she left I called her husband Rajesh Tassa to enquire about what had happened and he told me that she did not want to work at my place and wants to work at some other place.

7. A few days later, Puja Tassa had updated her Whats App Display Picture wearing my wife's clothes. When my wife saw this she was alarmed and checked what else she might have stolen. We got to know that she had stolen four of my wife's clothes, a gold biscuit (20 gms) and Rs. 23,500/- from my son's birthday gift which was kept in an envelope. After getting to know about this I immediately called Rajesh Tassa and asked him to come to my flat.

8. After he arrived, I told him about what had happened and tell his wife. He denied knowing any of that sort but he told me that she had stolen at Air Force Station Quarter at Air Force Station, Dinjan (Assam) and she was evicted from the servant's Quarter and was blacklisted from the Air Force Station, Dinjan (Assam). He assured me that he will talk with his wife and come back and inform me immediately. When he came back after he started crying saying that he will give back everything that she had stolen and pay off the debt that he owed me as soon as possible. He even assured me saying that he will sell his land and pay back the loan and not to file any complaint with the police. I felt bad for him and believed him.


9. As I was posted at Darjeeling since a few months I couldn't follow up the payments from him. He paid Rs. 2000/- in cash after two months of my confrontation and also asked me for time.

10. On 24<sup>th</sup> of July, 2022 I tried calling Rajesh Tassa but he didn't answer my call and I having no other options contact him I sent a voice message. The same day at around 9:37 pm I got a call from an unknown number (+91 8584887839). The person from the other side introduced himself as Satyendar Kumar Yadav, and said that he is the boss of Siliguri. He started abusing me and threatening to kill me and my family. He threatened me that if I ever call his friend Puja Tassa or her husband Rajesh Tassa he will file a false complaint of sexual harassment and torture against me. If I went too far then he will kill me and my family.

11. After some time, Rajesh Tassa, Satyendar Kumar Yadav along with 8 others entered inside my society gate and started abusing and shouting loudly. The security guard along with the secretary of the society somehow managed to keep them outside the society's premises. I called the police at this instance but they fled away from the spot when they saw the police were coming. When the police arrived at the spot they had already fled away and no one was at the spot.

12. My family and I fear for our lives. They will be responsible for any untoward incident that happens to me and my family in the near future and would like to request you to accept this complaint and register an FIR and take necessary action against these people.


