Sir,

In producing here with the seized articles viz:-

- (i) 02 (One) no's Indane domestic Gas Cylinder partially loaded
- (ii) 02 (two) no's HP domestic Gas Cylinder partially loaded
- (iii) 01 (one) Small Non branded Gas Cylinder partially loaded
- (iv) 01 (one) gas pipe length about 04 (four) fit with fitted one gas Regulator
- (v) 01 gas refilling Nozzle



Under proper seizure list I SI Goutam Kundu of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge a written complaint against the accused person namely Ratan Haldar (42yrs) S/O Kalipada Haldar of Madhya Santinagar Binoy more Pipe line Bazar, PS. Bhaktinagar, Dist- Jalpaiguri to the effect that on 28/07/2022 at about 13:45 hrs as per source information that the above noted accused person is illegally storing, refilling and selling Domestic LPG cylinders i.e. Indane and HP, at his shop for the purpose of refilling and selling in open market without any valid license or documents for his wrongful gain.

Accordingly the matter informed to the superiors. As per direction of superiors I, along with SI Pradip Chakraborty, ASI Prashanta Bardhan, ASI Ashoke Biswas, C/424 Manik Roy, CV/019 Debendra Nath Roy all of EB with investigation kit left for Bhaktinagar PS vide EB SPC M.C.C No 108/22 Dt.28.07.2022. The matters informed to Bhaktinagar PS vide GDE No. 1504/22 Dt.29.07.2022 and accompanied with mobile officer SI Harish Ch Basak, C/561 R. Gurung, C/1426 P.K Dutta all of Bhaktinagar PS vide Bhaktinagar PS MCC No 684 /22 Dt.28.07.22 had been to "MAA TARA GAS SERVICE CENTRE" located at of Madhya Santinagar Binoy more Pipe line Bazar, PS. Bhaktinagar, Dist- Jalpaiguri to work out the information and brief them about the information in hand and requested them to accompany with us during search and seizure, At about 14:45 hrs we reached at "MAA TARA GAS CENTRE" located at Madhya Santinagar Binoy more Pipe line Bazar, PS. Bhaktinagar, Dist- Jalpaiguri, as per source information I along with other officer and force conducted raid in the shop styled as "MAA TARA GAS CENTRE" of Ratan Haldar. On seeing the Police party the shop owner namely Ratan Haldar fled away from the shop for avoid police arrest.

I managed an independent 03(three) witnesses namely 1).Swapan Sarkar (50yrs S/O Kalidas Sarkar of Madhya Santinagar Binoy more Pipe line Bazar, PS. Bhaktinagar, Dist- Jalpaiguri, 2) Samir Guha (32yrs) S/o Gopal Guha of Bharat Nagar Prantic pally, Ward No.24 Rabindra Sarani, PS-Siliguri, Dist- Darjeeling and 3).C/424 Manik Roy of Enforcement Branch SPC. Nobody came that place and nobody produced any valid documents/ License in respect of above noted Gas cylinder. It is crystal clear that the absconding accused person namely Ratan Haldar (42yrs) S/O Kalipada Haldar of Madhya Santinagar Binoy more Pipe line Bazar, PS. Bhaktinagar, Dist- Jalpaiguri is storing, refilling and selling the Domestic cylinders in his shop for his wrongful gain. As per local enquiry it came to light that he negligent conduct with respect to fire or combustible matter, any act so rashly or negligently as to endanger human life or to be likely to cause hurt or injury to person that bazaar area and no valid License/Permit of dealing/distribution/refilling LPG. Thus the above noted accused person violated the provision West Bengal Cooking Gas (License and Control) order 1985. Accordingly I seized the above noted Domestic INDANE/HP and Non-branded Gas cylinders with gas pipe regulator and gas refilling Nozzle under proper seizure list in presence of independent witness above noted under proper seizure list in presence of witnesses. The seizure was made in between 15:15 hrs. to 15:45hrs.

Hence, I pray before you that a specific case U/S 285 IPC R/W Sec. 7(1)(a)(b)(c) of EC Act 1955 may kindly be initiated against the accused person namely "Ratan Haldar (42yrs) S/O Kalipada Haldar of Madhya Santinagar Binoy more Pipe line Bazar, PS. Bhaktinagar, Dist- Jalpaiguri." and arrange for its investigation.
