that time my co-tenants namely, (1) Md. Aashique
S/o md. Suraj (2) Fulfuli Begam w/o md. Suraj
both one of them residing at the same house noted
above and their relatives namely (3) Nazma
Begam w/o md. Kabir, of Vivekananda Nagar,
(Near Railway Track), Ward No. 7 SMC, P.O-
Siliguri Bazar, P.S-Siliguri, Distt-Dajelley, started
abusing me in filthy languages and when I
protested, they started beating me with fist
