Sir,

I, **SRI CHANCHAL KUJUR @ CHANCHAL ORAON**, Son of Late Phakir Kujur @ Phakira Oraon, resident of Uttambhita, Post Office Chowpukuria, Police Station Phansidewa, District Darjeeling, under Siliguri Police Commissionerate, do hereby beg to state as follows :

1. That I am the owner of land measuring 1.00 Acres, appertaining to R.S. Plot No. 128, corresponding to L.R. Plot No. 135 - area measuring 0.35 Acres and in L.R. Plot No. 137 - area measuring 0.65 Acres, recorded in R.S. Khatian No. 35/19, situated in Mouza RANGAPANI, J.L. No. 105, under Police Station Naxalbari now Bagdogra, District Darjeeling, having permanent, heritable and transferable right, title and interest therein, free from all encumbrances and charges whatsoever. I am a poor person belonging to Schedule Tribe Community.

That for the last few months, SRI PARITOSH BHOWMICK, Son of Bhupendra Nath Bhowmick, resident of Najrul Sarani, Ashrampara, near Maya Sanyal Nursing Home, Post Office & Police Station Siliguri, District Darjeeling along with his men are trying to encroach the suit land unlawfully and illegally for his wrongful gain.
