

Subject : Complaint for cheating, impersonation by means of false, fabrication and tampering of land documents.

Respected Sir,

This is to inform you that my wife, viz Manjila Khatun, R/o Panchkulguri, Dist - Darjeeling, is the owner of land measuring 10 located at LR Plot No 596, of Mauza Panchkulguri, JL No 59, earlier, P/S Matigara, Dist Darjeeling, by virtue of a registered Deed of Conveyance, Being No I-6591/2016, dated 26/09/2016, registered at the Office of District Sub Registrar at Siliguri. Subsequently, my wife mutated her name in the ROR (Record of Rights) and obtained a new LR Khatian Number 2516 of of Mauza Panchkulguri, JL No 59, earlier, P/S Matigara, Dist Darjeeling.

That recently on 25/07/2022, I found out that the accused person viz **1. Manjila Khatun @ Manjila Begum, and her husband 2. Md Tahidul**, both R/o Panchkulguri, P/o Nema, P/S Matigara, Dist- Darjeeling, has impersonated as my wife and sold out three and half katthas land to one Bishal Chettri, S/o Sri Kul Bahadur Chettri, R/O Chiriya Kothi, Middle Harsing Hatta Dist Darjeeling, by virtue of a registered Deed of Conveyance, Being No I-3954/2020, dated 16/10/2020, registered at the Office of District Sub Registrar at Siliguri. Subsequently, the above buyer mutated his name in the ROR (Record of Rights) and obtained a new LR Khatian Number 2944, of Mauza Panchkulguri, JL No 59, earlier, P/S Matigara, Dist Darjeeling.

That a few days back I discovered that the above accused persons by way of misrepresentation and impersonating as my wife based on false documents and duplicated Voter ID Cards sold off part of my land without my knowledge and consent. No information or clue of any kind whatsoever was given to us at the time of disposing the said land.

That the accused persons have deceived and cheated us of our hard earned assets sold off by impersonating as my wife through a well crafted conspiracy. On the basis of false, tampered and fabricated documents, viz voter ID card they have have sold off my land. That yesterday when I and my wife confronted the accused person we were scolded, and intimidated with derogatory and insulting verbal abuses, unparliamentarily phrases which utterly humiliated us.

In view of the above, it is most respectfully requested that my complaint may be looked into and appropriate action within the ambit of law may be taken against the above accused person and her husband.
