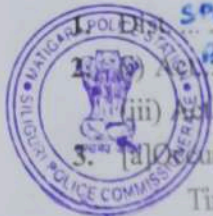

Sir,

In producing herewith arrested accused person named Raj Cheetri (49 yrs), S/O Lt. Ganesh Prasad Chhetri of Kadamtala, Durgamandir P.O-Kadamtala, P.S- Matigara, Dist.-Darjeeling along with memo of arrest, seizure list and seized articles viz 12 (twelve) Sealed Bottles of Kingfisher Strong premium Beer containing 650 MI each @ Rs. 120/-, 2 (Two) bottles Mc Dowells No 1 Superior Whisky containing 750 MI each @ Rs. 590/- and 1 (One) bottle Officer Choice Delux Whisky containing 750 MI @ Rs. 500/- and submitting a written complaint against him.

The fact of the case is that today on 30.07.2022 while performing Evening Van duty, received a source information that one Raj Cheetri (49 yrs), S/O Lt. Ganesh Prasad Chhetri of Kadamtala, Durgamandir P.O-Kadamtala, P.S- Matigara, Dist.-Darjeeling is carrying huge quantity of I.D liquor illegally and going toward Durgamindir for sale to the interested people for his wrongful gain.

I informed the matter to O/C NBMC OP and as per his direction I along with force, C/500 Mayaram Oraon, ⁶⁹⁸ Partha Biswas left for Durgamindir to work out the information. At about 18:35 hrs we apprehended the above mentioned person at Durgamandir area and on question he disclosed his name and address as above. On search above noted liquors have been recovered from his possession. On demand he could not produce any documents / License for possession such quantity of I.D liquor. On interrogation he confessed that he procured the said I.D liquor illegally for sale to the interested persons for his wrongful gain.


So, I seized 12 (twelve) Sealed Bottles of Kingfisher Strong premium Beer containing 650 MI each @ Rs. 120/-, 2 (Two) bottles Mc Dowells No 1 Superior Whisky containing 750 MI each @ Rs. 590/- and 1 (One) bottle Officer Choice Delux Whisky containing 750 MI @ Rs. 500/- in presence and duly signed by the witnesses under proper seizure memo and arrested him U/S 41 Cr.P.C.

Under the above circumstances I pray before your kind self that a specific case under proper section of law may kindly be initiated against the accused person named Raj Cheetri (49 yrs), S/O Lt. Ganesh Prasad Chhetri of Kadamtala, Durgamandir P.O-Kadamtala, P.S- Matigara, Dist.-Darjeeling and kindly arrange for its investigation.


