Respected Sir,

With due respect, I, **SMT. JYOTI PAUL**, Wife of Sri Pradip Paul, Resident of Madhya Shanti Nagar, Dabgram, Near St. Xaviers School, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to lodge this written complaint to the effect that I being a housewife, used to work as a seamstress on and from my house and whatever the amount I have earned from my said work, I used to save the same in order to maintain our family smoothly. Sir, in the month of March, 2021, one of our neighbor namely **SRI GANESH SARKAR**, Son of Sri Hiralal Sarkar, of Madhya Shanti Nagar, Dabgram, P.S. Bhaktinagar, Dist. Jalpaiguri, came in our house and requested me to provide some financial assistance of Rs. 30,000/- only to him as loan for his business purpose and also induced and provoked me by saying that if I pay the said amount to him, he shall return back the said amount along with interest to me within a period of one month. Sir, considering the neighboring relation and also believing his said version to be true, I have induced by him and agreed to pay the said amount to him from my own savings and accordingly, I have paid a sum of Rs. 30,000/- only to said Ganesh Sarkar in the month of March, 2021 and at the time of receiving the said amount from me, he did not issue any receipt and also induced me by saying that there is no need to issue any receipt as he shall pay the entire amount along with interest to me within a period of one month and on being induced by said Ganesh Sarkar and believing his version to be true, I have agreed with his said version. Sir, immediately after completion of one month from the date of received of the said amount from me, when I asked and requested him to return back the said amount as per his assurance, he did not pay any heed to my request and also tried to neglect the matter on different pretext and also tried to induce me by saying that he has invested the said amount for gaining more profit and I will be more benefited if I will wait for some more time and on being induced by him, I again

agreed with his said proposal but day by day, he delayed the matter on different pretext. Sir, again in the month of June, 2021, when I asked and requested him to return back the said amount as I was in need of urgent money, he has failed to return back my said amount and asked me to give some time to return back the said amount and accordingly, on 05.06.2021, said Ganesh Sarkar made a Self Declaration by putting his signature and assured me that he shall return back the entire amount within a period of one month but even after elapse of the said period, he did not return back the said amount to me inspite of my repeated request and demands. Sir, since then, on several occasions, I have asked and requested said Ganesh Sarkar to return back my said amount but he did not pay any heed to my said request but I did not take any legal steps against him considering our neighboring relation. Sir, recently, I again met with said Ganesh Sarkar with a request to return back my said amount which he has taken from me with some false promise and constant inducement but said Ganesh Sarkar flatly refused to return back the said amount to me and also threatened me with dire consequences and when I make protest against his said acts and activities, he became more furious and started to abuse me with filthy and abusive languages which tentamounts to the modesty of a women and also threatened me that he will not pay any amount to me and if I again asked him to return back the said amount, he will not hesitate to ruin my life permanently.

I, therefore, request you to kindly investigate into the matter and please take necessary legal steps against said Ganesh Sarkar in accordance with law and obliged thereby.
