- I, **SRI SEKHAR CHATTERJEE**, S/O Shankar Chatterjee, Resident of Madhya Shanti Nagar, P.O.- Dabgram-II (Shanti Nagar), P.S.-Bhaktinagar, Dist Jalpaiguri, I would like to serve this notice upon you stating as follows:-
- 1) That my son namely Sourajit Chatterjee was born on 11.08.2015 is residing with me.
- 2) That my wife namely Ritwika Chatterjee left me and my son on 20.10.2020 with one unknown person and since then she never ever came back to my house.
- 3) That subsequently finding no other alternative I filed one Divorce case against my wife which is pending before the Ld. F.T.C. Court at Siliguri.
- 4) That after when she left me and my minor son, my parents who are senior citizen used to look after my minor son till today.
- 5) That my7 wife also filed a Divorce case against me, which is pending at Jalpaiguri District Court and also Guardianship Case which is also pending at District Court at Jalpaiguri.
- 6) That since last one month my wife namely Ritwika Chatterjee, father-in-law namely Pradip Kumar Ray, mother-in-law namely Kalpana Ray, brother-in-law Prabir Ray and Pratap Roy and said unknown person with my wife left us and is residing as Husband and wife, started to take my minor son forcefully from me and my family members without the consent of us.
- 7) That whenever my son used to go outside of our house the above named persons used to forcefully take away my minor son to their house and when my minor son protested and started to cry they used to show me fear and forcefully kidnapped my minor son to their house

and when I and my parents visit their house to take back the minor son, they used to use filthy languages and started to threatened us that they will kidnap minor son and will implicate us in false cases.

8) That today. i.e., on 29.07.2022 at about 5:00 p.m. when my father took my minor son to the sweet shop at Amtala Bazar then the above named accused persons attacked my father and started to beat him mercilessly and broke the finger of the right hand of my father and tried to kidnap my minor son but my father somehow resist them and the above named accused persons demanded Rs. 5,00,000/- from my father otherwise they will kidnap my son and after that we will never see the face of my minor son

I therefore request before your good self to kindly look into the matter and take necessary strong action against the above named persons namely my wife namely Ritwika Chatterjee, father-in-law namely Pradip Kumar Ray, mother-in-law namely Kalpana Ray, brother-in-law Prabir Ray and Pratap Roy as per the provision of law and for this act of kindness I shall remain extremely great full to you.
