In producing here with the one arrested accused person namely (1) Astella Louis (F/61) W/0-Lt Antony Lurdu Louis of Salugara, Raj fapri, Durga Malla Path, P.S. - Bhaktinagar, Dist-Jalpaiguri along with the following seized articles as per proper seizure list

1. 12 (twelve) bottles of Himalayan Gold 60up Country Spirit (each bottle containing 600ML)

2. 06 (Six) bottles of Kingfisher Strong beer (each bottle containing 650ML)

4. ASF Dipak Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above noted accused parson to the effect that on 30.07.2022 while performing special raid duty under Bhaktinagar PS area vide BKN PS GDE No. 1614 Dated 30.07.2022 at about 15.05 Hrs I received source information that the above noted person have possessed huge amount of Liquor at Raj Fapri under Bhakti Nagar PS for the purpose of selling the same to local customers. Accordingly the information shared before you and as per your kind direction Lalong with Constable CV/619 Dharmendra Roy, CVF/ 614 Sumit Kumar Roy LCV/1060 Goma Bhandari neaded towards Raj Fapri to verify the veracity of the information. At about 15.25 hrs we reached at Raj Fapri and as shown and being identified by the source held raid at the above noted person Shop and apprehended one person who disclosed this identity as noted above. Further maintaining her decency and observing all formalities searched her and recovered huge amount of above noted seized liquor from her possession. On demand she could not produce any valid documents/licence in respect of the recovered liquor. On enquiry the apprehended person admitted her guilt and confessed that she have possessed above noted liquor at her house for the purpose of selling to her designed customers. She also stated that she have been doing this illegally since long without any valid licence or Documents for her wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 15.35 Hrs to 16.05 Hrs. As she has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising her ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Astella Louis (F/61) W/O- Lt Antony Lurdu Louis of Salugara, Raj fapri, Durga Maila Path, P.S. - Bhaktmagar, Dist-Jalpaiguri under proper section of law and arrange for its investigation.
