In producing herewith one arrested person namely Lila Devi Sahani (38/F) W/O Bilash Sahani of Santoshi Nagar, Machli Bazar, Ward No. 05, PS- Siliguri, Dist- Darjeeling along with 10 (ten) bottles of Himalaya Gold 60up Country spirit each bottles containing 600 ML. & MRP Rs 120/- each bottle Total RS. 1200/- Only. (one thousand two hundred only)

I ASI Jinnat Ali of Khalpara TOP, PS Siliguri under Siliguri Police Commissionerate, do here by lodge a written complaint against the above noted person to the effect that on 30.07.2022 while I performing K-27 mobile van at 14.45 hrs received an information that one person has gather the huge quantity of illegal liquor which was kept in her bag at Machli Bazar, Santoshi Nagar, Khalpara under PS- Siliguri, Dist- Darjeeling and sailing it for her wrong full gain. As per information I inform to O/C Khalpara TOP under Siliguri PS and as per his kind direction myself along with force proceeded to the PO to work out the information. At 15.05 hrs we reached at Machli Bazar, Santoshi Nagar, Khalpara under PS- Siliguri, Dist- Darjeeling same times after being identified by the source our police party held raid and recovered the above noted articles from the possession of above noted person. On demand she could not produced any valid license/documents in support of said liquor. She become nervous and admitted her guilt before us and stated that she sell the same in open market for her wrong full gain. In presence of witnesses I seized the above noted articles from her possession after prepared proper seizer list and with level and took signature of the accused person on one bottles taken as sample. The seizure was made in between 15.25 hrs to 15.55hrs. I arrested the accused person U/S 41 Cr. P.C and issued Memo of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Lila Devi Sahani (38/F) W/O Bilash Sahani of Santoshi Nagar, Machli Bazar, Ward No. 05, PS- Siliguri, Dist- Darjeeling under proper section of law and arrange for investigation.
