In producing herewith arrested accused lady namely (i) Jyosna Bibi(34yrs) W/o- Ashadul Haque of Tikiapara, Matangini- II, W/no- 28, PS- Siliguri, Dist-Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz: i) Nine(09) Sealed Bottles Himalayan Gold premium 60 Up Country Spirit each containing 600 Ml each labeled as Himalayan Endeavour PVT Ltd. Siliguri, West Bengal @ Rs 120 each(Amounting of Rs. 120/\*09=Rs 1080/-), in which one sealed bottle has taken from mother packet box as sample under proper seizure list, labeling and memo of arrest.

I, PSI Sumit Rawat of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused lady namely Jyosna Bibi(34yrs) W/o- Ashadul Haque of Tikiapara, Matangini- II, W/no- 28, PS- Siliguri, Dist-Darjeeling to the effect that on 30.07.22 at 15.35 hrs acting on secret source information that the above noted lady was busy to sale Id Liquor illegally at her shop situated at Tikiapara, Matangini- II, W/no- 28 under Siliguri PS in order to clandestinely dispose the same. Accordingly I informed the fact to IC Siliguri PS and as per his direction I along with other officer and forces left for Tikiapara, Matangini, W/no-28 under Siliguri PS vide GDE no- 1738 dated 30/07/22. On reaching at 15:45 hrs there and as identified by the source cordoned the above noted area where she was selling illegal alcohol. On seeing the police party the above noted lady tried to escape from the spot but with the help of lady force LC 1282 Swastika Sharma we manage to apprehend the above noted lady and on interrogation she disclosed her identity as noted above. On being asked she stated that she used to sale the 60 up country Spirit to locality without any valid documents as she violated the norms of Bengal Excise Act for selling the said Liquor without any valid License. On search i) Nine (09) Sealed Bottles Himalayan Gold premium 60 Up Country Spirit each containing 600 Ml each labeled as Himalayan Endeavour PVT Ltd. Siliguri, West Bengal @ Rs 120 each(Amounting of Rs. 120/\*09=Rs 1080/-) in which one sealed bottle has taken from mother packet box as sample as per seizure list which was kept concealed in her house under Siliguri PS. On being interrogation she could not produce any valid documents in respect of said liquor. She also stated that she is doing this Liquor business since long for her wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 15:55 hrs to 16:25 hrs. As such I arrested her with the help of lady force LC 1282 Swastika Sharma U/S- 41 Cr.P.C after observing all legal formalities.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused lady namely Jyosna Bibi (34yrs) W/o- Ashadul Haque of Tikiapara, Matangini- II, W/no- 28, PS- Siliguri, Dist-Darjeeling along with seized articles under proper section of law and arrange for its investigation.
