(Total market value RS/- 120 X +1 = Rs1320/-) from the possession of Radhe Ghosh (50) s/o Late Balai Ghosh of Haking Para Nigam pally road ward no 15 PS- Siliguri Dist- Darjeeling, in presence of witnesses- i. Arua Saha (53) S. o. Li Fatik Chandra Saha of Saha Bhandar of Rabindra Nagar, Near Dudh more, ward no 21 PS Schgar, Ord- Darjeeling, 2. Pranab Biswas (29) S/O Sri Soumen Biswas of Sukanta Nagar, near Kundu Pukar Mails 8 and no 38 PS.
