I. ASI Ratan Kr. Ghosh of Panitanki TOP under Siliguri PS do herby lodge a written complaint against the above noted accused person to the effect that today on 30/07/2022 at 19:15 hrs in course of K-28 Evening Van duty I received secret source information that, one person is carrying huge quantity of country spirit in a rylon bag moving towards at Lala Lajpath Roy Road, Ashrampara, under Panitanki TOP area. And on search the nylon bag which was he carrying on his hand and on counting in presence of the witness recovered total i) 07 (Seven) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD content 600 ml each when packed, MRP Rs. 120/- each. (ii) 02 (Two) Bottle of 80 Up Country Sprit styled as HIMALAYAN TUK TUK content 600 ml each when packed, MRP Rs. 55/- each. (iii) 01 (One) Nylon Bag which used for carrying the seized articles St. No- (1) & (II).

During interrogation the accused failed to produce any valid documents/license in support of the same with a suspect that he will procured the same for his ill motive illegally. Accordingly, I seized the same ie i) 07 (Seven) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD content 600 ml each when packed. MRP Rs. 120/- each. (ii) 02 (Two) Bottle of 80 Up Country Sprit styled as HIMALAYAN TUK TUK content 600 ml each when packed, MRP Rs. 55/- each. (iii) 01 (One) Nylon Bag which used for carrying the seized articles SL No- (I) & (II) under proper seizure list and labeled the same in presence of police witnesses and duly sign by them and also by the accused person.
