Sir,

I **SMT SUSHILA BARMAN**, wife of Sri Gouri Barman at present residing at C/O **MANAGER SHA** of Dry Fish market, P.O. & P.S. Matigara, District Darjeeling, Pin-734010, likes to inform you that since the year 2008 I was working as a maid servant and also look after Sri **MANAGER SHA** son of Late Ram Gobind Sha of Dry Fish market, P.O. & P.S. Matigara, District Darjeeling, Pin-734010 property and have been residing his house since the year 2008.

It is mention here that since the year 2008 no one of the family member's including his son namely **KAPUR CHAND SAH**, son of **MANAGER SHA** of P.S. Mafasil, District Siwan (Bihar) did not look after their father since long and except me no one of his family member did not keep any relation with **SRI MANAGER SHA** son of late Ram Gobind Sha.

It is also mention here that I have properly look after Sri **MANAGER SHA** and taking care each and every day and also treated him by the doctor of Chennai two times and Patna two times. I took him to Patna and Chennai for treatment purpose and **stayed there long period at that time** no one of his family members accompanied him for his treatment.

That **MANAGER SHA** died on 16/02/2022 at his home at Matigara and before his death he executed a will in favour of me on 24/06/2020 and by the said will he bequeathed his land and two storied building in favour of me and I like to file a probate case before the competent Court of Law.

That again on 23/07/2022 at about 8:30 A.M (morning) his son namely 1.**KAPUR CHAND SHA**, Grand son **AMOD SHA**, **PROMAD SHA**, **GOBINDA**

SHA all are son of Kapur Sha, **SMT ANITA DEVI** wife of **AMOD SHA** and wives of **PROMOD SHA** and **GOBIND SHA** suddenly forcefully along with some hooligans and Dalal of that locality forcefully entered in my room of the said house and all the male members are caught hold my hair and assaulted me physically and **KAPUR CHAND SHA** torned my Saree and Blouse and touched my private parts and using filthy language and threatened me with dear consequences that if I will stay on the said building furthermore they will rape and kill me.

In the aforesaid circumstances I like to pray to your goodself please do necessary action against above named accused persons and do the needful so that I can reside the home of **MANAGER SHA** which was bequeathed by him to me peacefully and please provide police protection to me so that I can stay in the said house.
