With due respect and humble submission, in producing herewith one accused namely Rajib Mahato (28) S/O Lt. Mahaswar Mahato of Dhaknikata, P.S- Pradhannagar, Dist. Darjeeling, under arrest along with following articles under proper seizure;

- i) **30(Thirty) Plastic bottles of 70 UP, Country Spirit, KACHI each bottle containing 300 ML, Biended & Bottled by Prakash Disittery & Chemical Co (P) Ltd, Bandri Jote, Pradhannagar, Siliguri**

I ASI Subir Sen of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today i.e on 30.07.22 myself along with force C/762 Majibar Rahaman, CV/242 Rakesh Mongar & C/128 Ajay Kr Sahani all of Pradhannagar PS left for Patrolling duty at PS area, Vide Pradhannagar PS GDE No.1783 dtd.30.07.22 and during patrolling duty at 14.15 hrs I received a source information that one person named Rajib Mahato was storing and selling liquor illegally in his petty shop at Ragulated Market near Fish Maket under Pradhannagar PS. Accordingly I share the information with you, and as per your direction rush to the spot and as pointed by the source we apprehended the above noted person and on search his shop, recovered above noted articles, On demand he failed to produce any valid document in respect of recovered articles. On interrogation he admitted that he is selling the same illegally without obtaining valid document for her illegal gain. Accordingly, I seized & label the above noted articles in between 14.35 hrs to 14.55 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Rajib Mahato (28) S/O Lt. Mahaswar Mahato of Dhaknikata, P.S- Pradhannagar, Dist. Darjeeling and arrange for its investigation.
