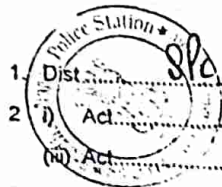

Sir,

In producing herewith one accused person namely Prema Rai @ Tamang (36) Yrs. S/O Late Ratan Rai of Bhanuram, Singmari, PS Sadar Darjeeling, Dist. Darjeeling (Not Verified) who has been arrest by me along with the following articles under seizure, seizure list and other relevant documents:-

- i. 56 Pieces of Diazepam Injection IP, containing 2 ml in each piece. B / No 5885, Mfd. 12/2021 and Expire Date: 5/2023 which is marked as "Exhibit -A"
- ii. 12 strip Promethazine Hydrochloride Injection I.P. Phenergan, each strip containing 5 pieces and 2 ml each containing in each pieces, which is marked as "Exhibit -B"
- iii. 55 Pieces Duprenorphine (Lupigesic) Injection I.P containing 2 ml in each pieces and which is marked as "Exhibit -C"
- iv. 01 (One) Pieces of Diazepam Injection IP containing 2 ml. B/No 5885, Mfd 12/2021 and expire Date 5/2023 taken from Exhibit - A as a sample for examination and marked as Exhibit - A-1"
- v. 01(One) strip Promethazine Hydrochloride Injection I.P. Phenergan, each strip containing 5 pieces and 2 ml. taken from Exhibit - B as a sample for examination marked as Exhibit -B-1"
- vi. 01(One) Pieces Duprenorphine (Lupigesic) Injection I.P, containing 2 ml. taken from Exhibit - C, as a sample for examination marked as Exhibit -C-1"
- vii. One black colure side bag which contained the above noted articles.

I, SI Rabindra Nath Sarkar of Pradhannagar P.S, SPC do hereby lodged this complaint to the effect that on 30.07.22 at 14.18 hrs I received a secret source information that one person carrying huge quantity of "Injection IP" in his possession at Siliguri Junction area for selling to the same to his design customer in high prize at Darjeeling area. Accordingly, I informed the information in hand to you and diarized in PS GDE No. 1784 Dtd. 30.07.2022. As per your order myself along with PSI Kalyan Saha, ASI Tarun Kanti Ghosh, C/762 Majibar Rahaman, CV/223 Swapan Cheetri, CV/128 Ajay Kr Sahani all of Pradhannagar PS left for Siliguri Junction under Pradhannagar PS by govt. vehicle WB-74AC-9851, vide Pradhannagar PS M.C.C No.1931 dtd. 30.07.22 & Pradhannagar PS GDE No. 1786 dtd. 30.07.22 at 14.25 hrs to verify the veracity of information. At the time of departure from PS I also contacted with the Videographer namely Somnath Chattarjee over phone for Videography of whole process, and also carry envelope, white paper, sealing wax, gum, seal etc. On reaching at Siliguri Junction I called two independent witnesses namely (i) Pravin Singh (42) S/O Lt Akhileswar Prasad Singh of Opposite Margarate School, P.S-Pradhannagar, Dist. Darjeeling & (ii) Md. Parvez (32) S/O Lt Md Nishar of Gurung Busty, Ward No. 3, P.S. -Pradhannagar, Dist. Darjeeling and briefed them about the information in hand and requested them to accompany us as independent witness if any search and seizure would be done. I also requested them by issuing a written letter for their consent to accompany us in the whole process during search and seizure if necessary, and obtain necessary permission of their presence as witnesses in the entire process of Search and Seizure under relevant provision of law. At about 14.55 hrs we arrived at place of occurrence and subsequently

being shown and identified by my source, we found one person was standing at Siliguri Junction bus terminus out gate, near Khan Tea Shop, who was carrying a one black colour side bag and waited there for pick up vehicle. Then we cordon him and detained him and disclosed him our identity as police personnel. On being asked he disclosed his identity as noted above. On further examination the above alleged person stated that he was carrying contraband Injection IP with him. Then I asked him whether he wanted to be search in presence of Executive Magistrate or any Gazetted Officer and he agreed to search by any one. I served him a notice in accordance with provisions of law in this regard. I also offered the independent witnesses and apprehended person to search our Police Party as per provision. But they refused to search the police party. Accordingly, I informed the matter to ACP, Enforcement Branch, Siliguri Police Commissionerate, Sri Manabendra Rakshit, WBPS and requested him to present at the spot as to day he detailed as Special Executive Magistrates, SPC vide C.O. No. 2291 Dt. 29.06.2022. Accordingly, at about 15.25hrs Sri Manabendra Rakshit, WBPS, Assistant Commissioner of Police, Enforcement Branch, Siliguri Police Commissionerate arrived at the spot. I disclosed his identity to the apprehended person and witnesses as a gazetted officer. Thereafter, under the supervision of Sri Manabendra Rakshit, WBPS, Assistant Commissioner of Police, Enforcement Branch, Siliguri Police Commissionerate and in presence of independent witnesses I conducted search of the above apprehended person keeping strict regard and recovered the Injection IPs from his bag as per seizure list which was possessing/carrying by the apprehended person. I seized the articles including the carry bag under proper seizure list and labeled, under the supervision of Sri Manabendra Rakshit, WBPS, Assistant Commissioner of Police, Enforcement Branch, Siliguri Police Commissionerate, in presence of witnesses as mentioned above and duly signed by them as well as the accused person and marked the seized exhibit as noted above. The whole process of seizure was made between 15.35 hrs and 16.35 hrs. On interrogation he admitted that he carrying the above noted articles for selling to his designed Customers at Darjeeling for higher amount of money for his wrongful gain. On being asked he failed to produce any documents or license in support of possessing/carrying of such drugs/Injection IPs. Then, I arrested the above noted accused person after observing all formalities of arrest and disclosed him cause of arrest and issued necessary Memo of Arrest as the accused person violated the terms and condition of N.D.P.S Act. I also collect the sample copy from the original seizure, which marked as A-1, B-1, & C-1. The entire procedure of search and seizure has been properly video graphed by the Videographer Somnath Chattarjee. On further interrogation he disclosed that he has been dealing in such illegal drugs since last several years and selling the same to the adjacent area of Darjeeling town with the help of his associates.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused namely Prema Rai @ Tamang (36) Yrs. S/O Late Ratan Rai of Bhanuram , Singmari , PS Sadar Darjeeling, Dist. Darjeeling (not verified) and arrange for its investigation.
