Respected Sir,

I, Rita Bansfore, W/o. Late Kailash Bansfore, R/o. Ho-Chi-Min Nagar, P.O. & P.S. Bagdogra, District Darjeeling West Bengal, India, would like to state that on 24-07-2022 at about 7.30 P.M. when I went coming from shop near Pioneer Ground suddenly 7 persons namely (1) Sunny Mahato (2) Upender Mahato, (3) Kameshwar Mahato, (4) Smt. Mina Devi Mahato, (5) Smt. Basanti Mahato, (6) Smt Kajal Mahato, (7) Meera Mahato, 1-2 sons of Kameshwar Mahato, No. 4 wife of Kameshwar Mahato, No. 5-7 D/o. Kameshwar Mahato & No. 6 wife of Sanjay Prasad ALL R/o. Bhujipani, P.O. & P.S. Bagdogra, District Darjeeling West Bengal, India, stated using abusive & filthy words on me. They always mentally abuse me by using the word "DOM & CHHOTA JAAT KA AURAT". When I asked them about why they are using such abusive & filthy words against me, they catch hold of me and physically assaulted me. They snatched my money amounting to Rs.3,000/- from my bag. They physically assaulted me due to which I sustained injury in my back. Thereafter the very next day i.e. on 25-07-2022 when I requested Basanti Mahato to return my hard earned money, she said that she will return the money after some days as she have used the money. She also requested me not to lodge any case as she will return the money. Later on 28-07-2022 again at about 4.30 P.M. when I saw Basanti Mahato and requested her to return the money back she called (1) Sunny Mahato (2) Upender Mahato, (3) Kameshwar Mahato, (4) Smt. Mina Devi Mahato, (5) Smt Kajal Mahato, (6) Meera Mahato, and again started abusing me. As I was alone I could not resist them. Due to god's grace I anyhow managed to get rid of their hand. I am shocked and in mental trauma.

It is requested before you in folded hand to kindly take strict necessary action against the abovenamed miscreant so that my money amounting to Rs.3,000/- can be recovered and they can be punished for their illegal acts.
