Sir,

In producing herewith 03 (three) seized Tractor having No. 1. WB-73-E-6761 2. WB-73-F-7126 3. BR-37-3877 loaded with river bed materials i.e. sand as per proper seizure list.

In this regards I ASI Subhash Ch Roy of Bagdogra PS , SPC lodged a written complaint to the effect that on 30.07.22 I alongwith force were performed morning mobile duty at Bagdogra PS area vide Bagdogra PS M.C.C. No. 2053/22 dt. 30.07.22 and at 09-10 hrs during mobile duty received information from duty officer of PS that the villagers of Chandal jote detained the above noted Tractors which was carrying river bed materials i.e. Sand with high speed of that area and over this the local people became furious for this illegal act which noted in Bagdogra PS GDE No. 1481 dt. 30.07.22. Accordingly as per direction of O.C PS I alongwith force reached at the spot i.e. Chandal Jote and found that the above noted Tractors loaded with river materials i.e. Sand are detained by the public but the driver of that vehicles flee away from there . On enquiry it could be learnt that the said Tractors loaded with sand illegally was coming from Chandal jote to Ranidanga side without proper documents/ papers in support of the carried substances (river bed materials). I searched the surrounding area, but no one came before me to claimant the same. Thus it is suspected that the organized racket in operation for carrying riverbed materials which may be theft illegally for wrongful gain and thereby causing huge revenue loss to the Government of W.B. As such I seized the above noted tractors loaded with river materials (Sand) under proper seizure list. The seizure was made in between 09-35 hrs to 10-55 hrs.

Under the above circumstances I pray that a specific case may kind be started against the driver of the above noted seized Tractor and arrange for its investigation.
