I, Dr. Bittu Singh, s/o. Ramesh Singh aged 33 years, residing at Salugara under P.S. Bhaktinagar, Dist. Jalpaiguri want to lodge a F.I.R. against the above vehicle number and the driver, about the accident that occurred yesterday night on 31/07/22 at about 10.20 p.m. at Salbari Bazar.

I and my friend were coming from Sulena to Siliguri and stopped at Salbari Bazar for some work, while my friend Md. Meeraj s/o Md. Yusuf aged 33 years residing at Ashrafnagar, under P.S. Bhaktinagar, Dist. Jalpaiguri was about to cross the other side of the road and the above vehicle number WB-74-AR 3624 which was silver colour and Mahindra KUV too which was coming from Siliguri and going towards Sulena in a high speed and that too in a wrong side and ran over him and my friend flew and fell on the road.

Then I, quickly picked him up and stopped a vehicle and took him to the nearest Green Age Hospital, at Dagaapur for emergency from where he was to higher centre as he was in a critical and serious conditions with his severe head injury, so I took him to Anandoke Super Speciality Hospital at Sevoke Road 2nd Mile, Siliguri for the emergency and got admitted in critical condition where the doctors shifted him to ICU (Intensive Care Unit), and put him on ventilator. Since yesterday night we were busy in Hospital, so, I have now written the F.I.R and want to lodge it today.

Request You to take necessary actions against the culprit and who is behind the accident.
