I Smt. Manisha Devi, W/o Surendra Ray, Permanent resident of Chainpur, Saran. Bihar, Pin-841424, Presently residing at Dakshin Majua, Deep Nagar, Siliguri like to inform you that on 29/7/2022 at around 11:30 AM we came to know that my minor daughter Priya Kumari aged about 16years went to outside from home. We try our best to search our daughter but not found any where. We intimated to the Panchayat of Champasari Gram Panchayat Smt. Pratima Thakur. On the next day 30/07/2022 at around 12.30 pm we went to Bhakti Nagar police station to give missing report. Panchayat of Champsari Gram Panchayat inform Bhakti Nagar Police in-Charge over telephone that Priya Kumari (my minor daughter) is found at Begusarai, Bihar with one Sawan Paswan, S/o Ramesh Paswan and also inform Police in-Charge that she (PratimaThakur) has shown us through video calling. But it was totally false, Sawan Paswan kidnapped my minor daughter (Priya Kumari) by seducing. After telephonic conversation, Police in-charge refuse to take missing diary and advised us to go back to home. On the next day on 31/07/2022 at our gram culprits **Sawan Paswan** along with all culprits namely **Pratima Thakur, Rajesh Thakur and Munna Paswan**, wife of **Munna Paswan, Ankit Paswan, Sarif Paswan, Nitish Paswan, Arun Paswan, Manisha Paswan, Puja Paswan, Jiban Paswan** and few local people forced us to give marriage my minor daughter with Sawan Paswan, On denial Pratima Thakur and her husband Rajesh Thakur assaulted us and push me with a threat of killing us if we try to take any legal steps.

So therefore, I would like to request you please accept my complain and give my minor daughter in our custody and take the appropriate legal action against the below mention culprits or take the necessary steps as you may think fit and proper.
