SUB: WRITTEN COMPLAINT

Respected Sir, Madam

I, Sumita Newar, D/O Man Bahadur Newar, aged about 31 years. permanent resident of Nijaiaguri, Nijaiaguri FV Part 1, P.O Shantipur, P.S Basugaon Dist Chirang in the state of Assam would kindly bring into your knowledge that in the month of January 2019 I had come to siliguri for visit and had been acquainted with one Sunny Thapa S/O Kishor Kumar Thapa and the said Sunny Thapa induced me to purchase a plot of land in Siliguri and after he took me to his home and introduced me to his families including his mother namely 1) Smt Kamala Thapa, W/O Shri Kishore Kumar Thapa, his father namely 2) Shri Kishore Kumar Thapa S/O Late Shyam Lal Thapa and his brother namely 3) Sanju Thapa S/o Shri Kishore Kumar Thapa all resident of Nabin Jote, P.O Nimai, P.S Matigara, Dist Darjeeling in the state of West Bengal and thereafter they built a family relationship with me and thereafter all the above named persons showed me a piece of land measuring 8.25 decimals at mouza nimal stating that Sunny Thapa is the owner of the said land and thereafter the said sunny thapa entered into a Deed of Agreement dated 05/02/2019 with me for the sale of the said land and thereby demanded an amount of Rs 12,50,000/- as the total sale consideration for the said land and relying on their representation I had paid an advance amount of Rs 7,00,000/- (Rupees Seven Lakhs) during execution of the said Deed of Agreement (copy of the same is annexed hereto as annexure 1) and after signing the said deed I further returned to my house at Assam, later in the year 2019 I had paid the remaining balance of Rs 5,50,000/- (Rupees Five Lakhs Thirty Thousand) only to and in favor of the said Sunny Thapa.

And thereafter the said Sunny Thapa, Smt Kamala Thapa, Shri Kishore Kumar Thapa and Sanju Thapa further asked me for Rs 60,000/- for the registration of the said land in my name and finally they called me at siliguri in their residence for handing over to me the registered sale deed in the month of November 2019 (copy of the same is annexed hereto as annexure 2), but sir they could not give me the khatian papers of the land in my name and later in the year 2021 when I forced them for khatian papers they said that the khatian could not be generated due to certain problems and further promised me to refund the entire consideration amount along with registration charged amounting to Rs 13,10,000/and handed over to me a blank cheque bearing no 453458 of State Bank of India from the account of Sunny Thapa vide executing an agreement in writing dated 29th day of April 2021 (copy of the agreement dated 29th day of April 2021 and the cheque is annexed hereto as annexure 3) that sir, even after handing over the said cheque the said sunny thapa along with , Smt Kamala Thapa, Shri Kishore Kumar Thapa and Sanju Thapa persistently called me and convinced me for not presenting the cheque as they had already searched another suitable land in siliguri and shall shortly get a Sale deed registered in my favor and believing on their promise and the family relation that they had built with me throughout the time I agreed to their request but the said Sunny Thapa, Smt Kamala Thapa, Shri Kishore Kumar Thapa and Sanju Thapa could not deliver me any land as promised till the month of May 2022 and they further started to neglect my calls as such finding no other alternative I came from Assam
