In producing herewith 02(two) arrested accused persons namely (i) Dulal Barman(22), S/O- Harekrishna Barman of Ambari, Belakoba, PS- Rajgunj, Dist- Jalpaiguri and (ii) Dalim Barman(32), S/O- Nidhi Krishna Barman of Shishabari, PO- New Rongia, PS- Matigara, Dist.- Darjeeling and the following articles under seizure. The ground of

1. One Black colour Motor Cycle displaying number plate WB/74/AT/0277 (Bajaj Palsar-135) 2. One Black colour VIVO Smart Mobile Phone.

3. One Multi (Black & Blue) colour VIVO Smart Mobile Phone.

4. One Black colour "VIVO Y12G" Smart Mobile Phone having IMEI1-867547057006555 & IMEI2-867547057006548. 5. One Black colour MI Xiaomi (model No MD11) Smart Mobile Phone

6. One Blue colour TECNO Spark Smart Mobile Phone having IMEII-35874361158794 & IMEI2-358743611587950.

I, SI Goutam Mallik of Matigara Police PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused Persons namely (i) Dulal Barman(22), S/O- Harekrishna Barman of Ambari, Belakoba, PS- Rajgunj, Dist- Jalpaiguri and (ii) Dalim Barman(32), S/O- Nidhi Krishna Barman of Shishabari, PO- New Rongia, PS- Matigara, Dist.- Darjeeling to the effect that on 02.08.2022 at 20.15hrs I received reliable secret source information that two persons came at Shishabari under Matigara PS with one stolen motor cycle along with some stolen mobile Phone to sale the same to their customers. Accordingly, I diarized the matter in General Diary vide Matigara PS GDE No 94, Dated 02.08.2022 and informed the fact to the Officer -In-Charge, Matigara PS and as per his kind order and direction myself along with PSI Shekhar Adhikary, ASI Dhirendra Nath Mandal, C/1053 Paresh Rava and C/974 Mintu Sen all of Matigara PS left for Shishabari under Matigara PS by Govt vehicle to verify the veracity of the information. At about 20.45hrs we reached at Shishabari under Matigara PS and from a considerable distance we noticed that two persons were standing with one black colour motor cycle at Shishabari near Salbagan. Seeing the police party they started to flee away toward Salbagan keeping their motor cycle on the road but after a hot chase we able to apprehended both of them. On being asked they disclosed their identity as noted above. On being searched of above mentioned Dulai Barman found One Black colour VIVO Smart Mobile Phone and One Multi (Black & Blue) colour VIVO Smart Mobile Phone which were kept in the right side pocket of Dulal Barman and One Black colour "VIVO Y12G" Smart Mobile Phone having IMEI1-867547057006555 & IMEI2-867547057006548 which was kept in the left side pocket of Dulal Barman. Subsequently being searched of above noted Dalim Barman found One Black colour MI Xiaomi (model No MD11) Smart Mobile Phone and One Blue colour TECNO Spark Smart Mobile Phone having IMEI1-35874361158794 & IMEI2-358743611587950 which were kept in the left side pocket of Dalim Barman. On demand they failed to produce any documents in respect of the motor cycles as well as of all 05(Five) mobile phones found in their possession. On interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with motor cycles and Mobile Phones. During further interrogation they disclosed that they have stolen the said motor cycles displaying number plate WB/74/AT/0277(Bajaj Plsar-135) & the mobile phones found from their possession and came there to sale the same to their designed customers. There was sufficient reason to believe that the said motor cycle displaying number plate WB/74/AT/0277 (Bajaj Palsar-135) and Mobiles are stolen. Accordingly, I seized the above noted motor cycle displaying number plate WB/74/AT/0277 (Bajaj Palsar-135) as well as mobile phones found from their possession under proper seizure list and arrested them under proper memo of arrest and observing all the formalities of arrest. The search seizure made in between 21.15hrs and 22.25hrs on 02.08.2022.

Under the above noted fact and circumstances, I therefore pray to you that a specific case under proper section of law may kindly be registered against accused namely (i) Dulal Barman(22), S/O- Harekrishna Barman of Ambari, Belakoba, PS- Rajgunj, Dist- Jalpaiguri and (ii) Dalim Barman(32), S/O- Nidhi Krishna Barman of Shishabari, PO- New Rongia, PS- Matigara, Dist.- Darjeeling and arrange for its investigation.
