With due regards, I, Smt. Rina Dutta, W/O. Late Bikash Ranjan Dutta, a permanent resident of "Manashi", New Jalpaiguri Gate Bazar would like to inform you that on 29th November 2006, marriage between my son Arunava Dutta and Madhumita Dutta@ Roy, D/O. Sh. Debobrata Roy was solemnized as per Hindu Rights, on 03-11-2020 my daughter in law Madhumita Dutta, who on material point of time was working as Sister in Charge, Gr. I (ii), Islampur Sub-Divisional Hospital, Dt- Uttardinajpur, under Dept. of Health and F.W., Govt. of W.B. had left the matrimonial home and the same was intimated to the NJP Police station on 04-11-2020.

Yesterday i.e on 03/04/2022 evening hours, I saw my grandson Arkaprava Dutta @ Rishi under the instruction of her mother along with some of their close aides had broken the lock of the door. When I objected to it's they showered filthy words on and abused me in manner not fit for human being. On enquiry my grandson disclosed that his mother has planned to trouble me in many ways and his associates/aides were all chosen by his mother. I have faced extreme physical and mental torture at the hands of my daughter in law. I have received threats from my daughter in law that "if my son is not inclined to consent for divorce, he would not see his mother again". She had also cautioned me that she is a skilful nurse and knows at least ten ways to kill someone which even cannot be identified by finest expert of forensic medicine since. My daughter in law is trying to obtain my son's consent for a divorce by putting him in fear of causing my death.

It is pertinent to mention that my daughter in law prior leaving the matrimonial house had also threaten and used abusive and filthy words against me which followed by physical & mental torture. In this regard all her previous activity was mentioned in clear and cogent manner in my complaint dated 04-11-2020. I live in a property exclusively owned and possessed by me and I have been running the risk of injury/ harm by my daughter -in -law or her associates due to the estranged relationship between my son and Madumita Dutta Roy.

Since I am a senior citizen, suffering different ailments and staying alone here my son is working as Demonstrator in the Department of Forensic Medicine & Toxicology, in a medical college at Chhattisgarh) is afraid of such activity of my daughter in law, grandson and their close associates. Further such activity of the above mentioned persons had created a sense of insecurity for me. If any harm cause to me in future then the above persons will be held responsible for the same. I reputed the matter immediately but went unnoticed by authorities.
