**SUB:- LODGING OF FIR**

It is to intimate that, 28<sup>th</sup> July 2022 special Ambush comprising No. 024017981 Insp Nand Kumar along with 04 Ors in the depth area of BOP Fulbari in the alightment of BP No. 732/3-S at Lockdown Morh near village Nipaniya has laid from 0010 to 0400 hrs. At about 0140 hrs party observed some suspicious movement of 15-20 miscreants/smugglers with cattle heads. The Ambush party immediately challenged them to stop but they did not pay any heed to it and aggressively towards the Ambush party and poured high beam torch lights towards Ambush party. Some of them have bamboo stick with them. On this, Insp Nand Kumar fired one by one 02 rounds of PAG. After that the miscreants/smugglers fled away from the spot by taking advantage thick overgrowth and darkness. The ambush party further searched the area and seized 14 Nos cattle Bengali origin medium size worth 14,459/- Total worth 2,02,426/- as outgoing/ unclaimed in depth area. And

On 29<sup>th</sup> July 2022 special Ambush comprising No. 024017981 Insp Nand Kumar along with 06 Ors in the depth area of BOP Fulbari in the alightment of BP No. 732 M at Asian highway-2 (Vill- Amedighi near Fulbari chowk) has laid from 0010 to 0400 hrs. At about 0210 hrs party observed some suspicious movement of 15-20 miscreants/ smugglers with cattle heads. The Ambush party immediately rushed towards the spot and seeing Ambush party the miscreants/smugglers fled away from the spot by taking advantage of darkness and bad weather. The ambush party further searched the area and seized 03 No's cattle Bengali origin big size worth 18,260/- Total worth 54,780/- and 08 No's cattle Bengali origin small size worth 12,033/- total 96,264 G. total 1,51,044/- as outgoing/ unclaimed in depth area.

The seized cattle has handed over to Dhyan Foundation, Kishanganj, Bihar. Seizure memo and handing taking certificate enclosed.
