Dear Sir,

I, SMT. PUJA MONDAL SARKAR, Wife of Sri Biswajit Sarkar, resident of D.S. Colony, Ward No. 34, Post Office Siliguri Town, Police Station New Jalpaiguri, District Jalpaiguri (W.B.) the undersigned, would like to bring to your kind notice and state as follows :

1. That my marriage was solemnized on 28.04.2019 with Biswajit Sarkar, Son of Gopal Sarkar of D.S. Colony, Ward No. 34, Post Office Siliguri Town, Police Station New Jalpaiguri, District Jalpaiguri (W.B.) and since then I am residing with my husband and his family members in the aforementioned address.
2. That out of our wedlock I also gave birth to a female child, namely Diya Sarkar on 24.06.2020. Presently I am 9 months pregnant and I am passing my days in physical stress. I am pregnant and my daughter is also infant.
3. That I reside in the said house along with my husband, Sri Biswajit Sarkar, my father-in-Law, Sri Gopal Sarkar, mother-in-law Smt. Sima Sarkar, brother-in-law Sri Ashish Sarkar, sister in law Smt. Sumitra Sarkar, Wife of Ashish Sarkar. My sister-in-law Smt. Chandana Paul Sarkar and her Husband Sri Gautam Paul, Son of Late Jyotin Paul also reside with us my home.
4. That my husband is a private service holder and he leaves house in the morning and returns home very late at night. During his absence my father-in-law, Sri Gopal Sarkar, mother in law, Smt. Sima Sarkar, My sister-in-law Smt. Chandana Paul Sarkar and her Husband Sri Gautam Paul regularly tortures me and my other sister in law Smt. Sumitra Sarkar both physically and mentally. Unable to bear such inhumane torture my said sister in law Smt. Sumitra Sarkar had earlier lodged a complaint with the New Jalpaiguri Police Station and a case being Siliguri Women P.S. Case No. 112 of 2014 was also started, however considering the relationship and also at the intervention of friends and relatives the said case was withdrawn/settled.
5. That inspite of the above facts, the said persons started casting inhumane torture upon me and my said sister in law and the said persons in collusion with each other have also lodged false complaint against my husband and others.
6. That on 28.06.2022, while I was going towards the well to fetch water I suddenly fell on the slippery ground and sustained severe back injury. I could notice that the ground was slippery as there was detergent water sprinkled on the ground. I am pregnant and any untoward incident could have occurred on the said date.

7. That thereafter on 05.07.2022 I could notice that my mother-in-law, Smt. Sima Sarkar and my sister -in - law Smt. Chandana Paul Sarkar were sprinkling detergent water on the ground with intention to cause harm me as I would fall while going to the well and suffer severe injury.
8. When I raised objection and asked them the reason for doing so, they became violent and stated that they want to kill my baby in my womb. On listening to such statement I raised hue and cry and hearing such commotion my father-in-law Sri Gopal Sarkar and the husband of my sister-in-law, Sri Gautam Paul, who were present in the house at that time rushed at the spot and all four of them started abusing me in filthy languages and also started assaulting me physically. They also pulled and torn my sarree and outraged my modesty. My sister in law Smt Sumitra Sarkar intervened and somehow rescued me from their hands.
9. That considering the attitude of the said persons and also for the sake of safety of my child and unborn child, I immediately left my matrimonial house and went to my paternal house at Khola Chand Fapri, Jungle mahal, Baikunthapur, Jalpaiguri.
10. That on 25.07.2022 I returned from my father's house to my matrimonial house for visiting my doctor as scheduled earlier and also for attending the marriage ceremony of my cousin sister-in law scheduled on 03.08.2022. However on 28.07.2022 while I was alone in my room with my daughter, my father in Law, Sri Gopal Sarkar, mother in law Sima Sarkar, sister-in-law Smt. Chandana Paul Sarkar and her Husband Sri Gautam Paul suddenly came to the door of my room and started abusing me in filthy languages and also cursing me. When I raised objection, the said persons entered my room and started assaulting me and also dragging me out of my room. I pleaded that I am pregnant and I cannot sustain such torture, but they did not pay any heed to my cry and assaulted me mercilessly.
11. That owing such assault and physical torture I sustained severe injury on my head, back, hand and other parts of my body including my private parts. I thereafter had to be medically treated by the doctor on 29.07.2022.

I therefore kindly pray before your goodself to kindly consider my prayer with sympathy and take immediate steps against my father in Law, **Sri Gopal Sarkar**, Son of Late Gogon Sarkar, my mother in law **Smt. Sima Sarkar**, my sister-in-law **Smt. Chandana Paul Sarkar** and her Husband **Sri Gautam Paul**, all residents of D.S. Colony, Ward No. 34, Post Office Siliguri Town, Police Station New Jalpaiguri, District Jalpaiguri (W.B.) and book them for the offences committed by them.
