**SUB:- LODGING OF FIR**

It is to intimate that, 31<sup>th</sup> July 2022 No. 111727881 CT Jutan Chakrabarty ex E coy 180 Bn BSF along with 02 ORs detailed to perform 2<sup>nd</sup> shift ACP duty from BFL No. 28 to 34, time from 0001 to 0600 hrs at ACP No. 01 of BOP Jumagach. They were performing duty ahead of fence. CT Jutan Chakrabarty was performing duty in between BFL No. 28 to 30. While performing the duty at about 0510 hrs (first light) he heard some sound towards the BFL No. 30. He immediately rushed towards the side and noticed 5-6 miscreants/smugglers were trying to fence breach. He immediately challenges them to stop. On this the miscreants/smugglers fled away from the spot to India side by taking advantage of undulated ground and foliage. And he noticed fence breach.
