I ASI Tarun Kanti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted two accused persons to the effect that today on 04.08.22 at 14.21 hrs myself along with force CV/128 Ajay Kr Sahani, CV/223 Swapan Chettri, CV/645 Pankaj Gupta all of Pradhannagar PS was performing special mobile at PS area vide Pradhannagar PS GDE No. 218 dtd.04.08.22. During patrolling at 14.55 hrs, I received a source information that two person has standing at Siliguri Junction area under Pradhannagar PS with two trolley bag and one hand bag with huge quantity illegal liquor. Accordingly I informed to you and as per your direction myself along with force arrived at Siliguri junction, and after arrival the spot I contacted with the source and the source identified them, accordingly we are apprehend them at Siliguri Junction, near Khan tea stall and on interrogation they disclosed their name noted above, they also stated that they used to bring illicit liquor from Sikkim in order to sell the same to their customer in Siliguri area for their wrongful gain. Accordingly I search the bags and recovered above noted articles, on demand they failed to produce any valid document in respect of recovered articles. Hence I seized & label the above noted articles in presence of local witnesses namely (1) Sri Naresh Kamti (35) S/O Promad Kamti of Rajendra Nagar Coolipara, P.S-Pradhannagar, Dist.darjeeling and (2) Sri Pawan Kumar Kamti (25) S/O Badlu Kamti of Amta, P.S- Behari, Dist. Darvanga, Bihar, at present C/O Bengal Safari, Siliguri Junction under Pradhannagar PS, Dist.Darjeeling. the seized was made in between 15.35 hrs and 16.15 hrs and I arrested them.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely (1) Manish Kumar (32 years) S/O Badri Narayan of Gobindpur, P.S-Amarpur, Dist. Banka, Bihar & (2) Dinkar Kumar (32 years) S/O Dhani Ram Tanti of Ghorpathia, P.S- Sahakun, Dist. Bhagalpur, Bihar and arrange for its investigation.
