With due respect and in producing herewith one person namely Kaushik Paul @ Tumpa (49), S/O- Lt. Krishnahori Paul of Rabindra Nagar, Ward No-22, PS- Siliguri, Dist- Darjeeling under arrest and one copy of Permission under Rule 239 of West Bengal Excise (F.L.) Rule, 1998 issued from the Superintendent of Excise, Darjeeling vide Memo No. 383/D/E Dated: 03.06.2022 to the 'Zizzi Restaurant Cum Bar (with one additional Bar) valid up to 22.03.2023 under proper seizure I, SI Goutam Mallik of Matigara Police Station, SPC do hereby lodged this written complaint against the above mentioned arrested accused person namely Kaushik Paul @ Tumpa Floor Manager of 'Zizzi Restaurant Cum Bar and the owner of the 'Zizzi Restaurant Cum Bar to the effect that on 07.08.2022 at 22.20 hrs onwards I along with other officers and force had been to City Centre Mall under PS- Matigara, Dist- Darjeeling for routine checking.

In course of routine checking, I along with other officers and force had been to 'Zizzi' Bar at City Centre Mall under PS- Matigara, Dist- Darjeeling and found music and singing was going on there. Subsequently, being asked, the Floor Manager of 'Zizzi Restaurant Cum Bar namely Kaushik Paul @ Tumpa, produced one copy of permission under Rule 239 of West Bengal Excise (F.L.) Rule, 1998 issued from the Superintendent of Excise, Darjeeling vide Memo No. 383/D/E Dated: 03.06.2022 to the 'Zizzi Restaurant Cum Bar (with one additional Bar) valid upto 22.03.2023 but, he failed to show /provide the CCTV Footage of the 'Zizzi' Bar and could not give any satisfactory reply for not preserving the CCTV footage as per the terms and condition of the permission as noted above.

Accordingly, I seized the copy permission under Rule 239 of West Bengal Excise (F.L.) Rule, 1998 issued from the Superintendent of Excise, Darjeeling vide Memo No. 383/D/E Dated: 03.06.2022 to the 'Zizzi Restaurant Cum Bar (with one additional Bar) valid upto 22.03.2023 under proper seizure list and also arrested above noted Kaushik Paul @ Tumpa under proper memo of arrest after informing the ground of his arrest for violating the norms and condition of the permission granted to the Zizzi Restaurant Cum Bar (with one additional Bar) by the Superintendent of Excise, Darjeeling vide Memo No. 383/D/E Dated: 03.06.2022.

Under the above noted fact and circumstances, I therefore pray to you that a specific case under proper section of law may kindly be recorded against the arrested accused namely Kaushik Paul @ Tumpa (49), S/O- Lt. Krishnahori Paul of Rabindra Nagar, Ward No-22, PS- Siliguri, Dist- Darjeeling and the owner of the 'Zizzi Restaurant Cum Bar at City Centre Mall under PS- Matigara, Dist- Darjeeling and arrange for its investigation.
