With due respect I, **MR. JACOB RYMBAI** Son of Late Mishel Rai , resident of Devi Chowrani Road, Salugara East, P. O. Salugara, SMC Ward No. 42, P. S. Bhaktinagar, District - Jalpaiguri (West Bengal) 734008 begs to state that I am patient of kidney failure and my treatment is going on under the supervision of doctors of Coimbatore, Tamilnadu.

That **SMT SAKUNTALA RAI @ SHERPA** W/O Mishel Rai, D/O Chhering Dorje Sherpa @ Tshiring Dorje Sherpa, is my mother and she entered into an agreement for sale of land measuring 10 kathas situated at Devi Chowrani Road, Salugara East, P. O. Salugara, SMC Ward No. 42, P. S. Bhaktinagar, District - Jalpaiguri (West Bengal). That said land is under Mouza Dabgram, Pragana Baikunthpur, Khatian No. 81(old) R.S 2045, Plot No. RS 77/233, 33/1, 39/231, with Deeki Sherpa, Daughter of Late Dawa Lama @ Kumar Sherpa of Salugara Bazar, P.O Salugara, P.S Bhaktinagar, Dist Jalpaiguri(West Bengal).

That 1) Smt Ranjana Gurung W/O Nima Gurung 2) Sri Pasang Lama @ Sonam Geljen Sherpa, S/O Late K.C. Sherpa and 3) Dendup Wangchuk Dukpa(Sherpa), S/O Not Know, 4) Smt Pasang Lama(Sherpa) Wife Of Late Wangdi Lama and 5) Yogesh Rai, S/O Not Known, all are residents of Salugara Bazar, Ward No. 42 of SMC, P.O. Salugara, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal induced my mother and to purchase the said land and on their inducement my mother, made a payment of Rs 31,50,000/-(Rupees Thirty One Lac Fifty Thousand only) on different date to aforesaid persons.

That from the very beginning their intention was/is to cheat my mother. That Smt Pasang Lama(Sherpa) Wife Of Late Wangdi Lama with collusion with Dendup Wangchuk Dukpa(Sherpa) and other land mafia on prepare false and fabricate documents of the land in their name and their intention to cheat my mother for illegal gain.

That my mother had filed one Title Suit being No. 14 of 2022 before the Ld. Civil Judge Senior Division, Jalpaiguri and the Ld. Court was pleased to pass an order of Injunction preventing the parties to create any third Party interest on 25.01.2022. Salugara, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal, Serial No. 3) presently residing at Tadong, Hotel Betila, Tadong, P.S Gangtok, Sikkim came to our land and started creating tension. The aforesaid person entered into the land and threatened me stating that they shall bring bulldozers and heavy machineries and demolish my structure in the said land. They threatened that they shall throw me out of my land and demolish the structure. They are also trying to sell the said land by unlawful means and grab the land for their ulterior motive. That the said land is protected by the injunction order of the Ld. Civil Judge Senior Division, Jalpaiguri and they have no respect and fear on the order of the Ld. Court.

That my mother is tribal by caste.

So I therefore request you to kindly look into the matter and do the needful against the aforesaid desperate person who has no respect for law.
