Sir,

In producing herewith one accused person namely (1) Bijay Barman (30) S/O Late Kolen Barman of Matigara Typist Market PS Matigara Dist Darjeeling in custody arrested and the following property weighing total 258(Two hundred fifty eight) grms said to be Brown Sugar under seizure:-

- i. (1) One packet said to be Brown Sugar wrapped in a polithin packet weight about 103(One hundred three) grms, Marked as exhibit - "A"
- ii. (1) One packet said to be Brown Sugar wrapped in a polithin packet weight about 102 (One hundred two) grms, Marked as exhibit - "B"
- iii. (1) One packet said to be Brown Sugar wrapped in a polithin packet weight about 53(Fifty three) grms, Marked as exhibit - "C"

I, S.I Pradip Kr Singha S/O Late Radhashyam Singha of Ashighar Out Post PS Bhaktinagar SPC do here by lodge this complaint to the effect that on 08.08.2022 at 19.25 hrs received a secret source information that one person is standing at, Kankata More, Ashighar and he possess huge quantity of Brown Sugar with a view to sale the same in Siliguri area and its adjoining area and he could be caught red handed, if apprehended immediately. Accordingly, I diarised the matter vide ASG OP G.D.E No.221 Dated-08.08.2022 and informed the matter to O/C Ashighar OP and as per his instruction myself along with ASI Krishna Ch Singha, C/729 Dinesh Ch Roy C/877 Munna Ahmed and CV/909 Nityananda Choudhury left for Kankata more area in a Govt vehicle along with weighing machine & investigation kit and Video Grapher namely Subhankar Mandal at 19.35 hrs to verify the veracity of the information vide ASG OP GDE No. 222 Dt.08.08.2022. On way to Kankata More I called two independent witnesses namely (i) Sujit Roy (31) S/O Late Satish Roy of Telipara Ashighar PS Bhaktinagar Dist. Jalpaiguri and (ii) Dipankar Saha (39) S/O Sankar Saha of Niranjana Nagar W/no. 36 Bidyasagar Sarani PS Bhaktinagar dist. Jalpaiguri and informed them about the information in hand and requested them to accompany us to witness for search and seizure if necessary. At about 19.45 hrs on arrival there as identified by the source we surrounded the person standing at Kankata More. On being asked he disclosed his identity as noted above. I informed him about the information in hand and he will be search. After disclosing our identity, I asked him whether he has any objection to be searched in presence of any Executive Magistrate or Gazetted officer and he agreed to be searched in presence of any Gazetted Officer. I served him a notice in accordance with the provisions of law in this regard. Then I send a notice to Shri Manabendu Sekhar Rakshit, ACP, EB SPC through special messenger with a request to appear at the spot and remain present as gazetted officer. After some times at about 20.25 hrs Shri Manabendu Sekhar Rakshit, ACP, EB SPC arrived at the spot. I narrated the whole fact to him and disclosed the identity of Shri Manabendu Sekhar Rakshit, ACP, EB SPC to the accused person as gazetted officer. Under supervision of Shri Manabendu Sekhar Rakshit, ACP, EB SPC the above noted accused person was searched keeping strict regard of his decency and recovered three numbers of packets of said to be Brown Sugar wrapped in polithin packets which he was kept conceal inside a orange & black

coloured hand bag, styled as Gupta Mobile. The accused person confessed in presence of Gazetted Officer and other witnesses that he procured the said Brown Sugar clandestinely from Amarpur, Murshidabad and other area for the purpose of its selling to the local youths of Siliguri and the adjacent area with a view to earn huge money quickly. On being asked he failed to produce any documents or license in support of his such possession. Then as per direction of Shri Manabendu Sekhar Rakshit, ACP, EB SPCl weighted the said packets of said to be Brown Sugar with weighing instrument which was kept with us and found the weight of recovered said to be Brown Sugar packets are (i) 103 Grms approx, (ii) 102 Grms approx & (iii) 53 Grms approx respectively, total weight 258 Grams. Then I packed, labeled and sealed the three numbers of recovered said to be Brown Sugar packets in presence of witnesses, and seized all the recovered articles under proper seizure list under the supervision of Shri Manabendu Sekhar Rakshit, ACP, EB SPCl signed by the local witnesses and the accused person. The seizure was made in between 20.40 hrs to 21.35 hrs. Then I arrested the above noted accused person after observing all formalities of arrest as well as after disclosing the cause of arrest and issued necessary memo of arrest. The copy of seizure list and memo of arrest have been supplied to the above noted accused person under receipt. Thus the accused person violated the terms and condition of N.D.P.S Act. for possessing Brown Sugar without any authority. The videography has been done of whole process by videographer.

Under the above circumstances, I pray to you that a specific case under NDPS Act may kindly be started against the accused person namely (1) Bijay Barman (30) S/O Late Kolen Barman of Matigara Typist Market PS Matigara Dist Darjeeling and arrange for its investigation.
