Respected Sir,

With due respect I Mamta Sarki W/O Sri Netra Bahadur Sarki, resident of Raj Phapri, P.S Bhaktinagar, Dist Jalpaiguri(west Bengal) begs to state that my husband is an employee of B.S.F and now posted at Panjipara. That I am residing at Raj Phapari, my elder son namely Sagar Sarki is a habituated ganja smoker & drunkard. That my father-in law Sri Nar Bahadur Sarki used to provide ganja and alcohol to my elder son. That my afore said father-in-law regularly convinced my elder son to beat me and drive me out of my own house. That today, without any rims and reason, my elder son and my father-in-law and along with my mother-in-law started assaulting me with fist and blows. That my father-in-law, Nar Bahadur Sarki and my mother-in-law Rita Sarki tried to outrage my modesty and they drove me out from my own house. That they also threatened me that they shall kill me if I returned to my place of residence or lodge any complaint before any authority. This type of incident had occurred several times earlier and occurs on a daily basis. That my son Sagar Sarki is regularly threatening me that he shall commit suicide and is threatening that he shall leave one written note blaming me for the suicide. That today at around 09:30 am the above named Sagar Sarki, S/O Netra Bahadur Sarki assaulted my daughter Anshu Sarki, D/O Netra Bahadur Sarki with fist and blows and threatened her with dire consequence with a motive to kill her. The above named Nar Bahadur Sarki and Rita Sarki are the abettor and are regularly abetting the actions of Sagar Sarki.

So, I therefore request before you to kindly look into the matter and start specific case against the accused person and do the needful. I shall be highly obliged for this act of kindness.
